6. Board Education - Adult Protective Services - Diane Cox - Scams:

- Diane reported that she is not involved with scams, as these will go through the police department.
- Diane did tell the board about the different types of elder abuse. These include: self-neglect, physical, neglect by others, financial exploitation, sexual and emotional abuse.
- Diane handed out a report showing the activities of all Adult Protective Service Activities in Richland County for 2016. There was a total of 103 reported incidents. The majority of the cases (73) were regarding self-neglect. This is people not being able to take care of themselves.
- Diane said that people generally do not report relatives.
- Diane informed the board that there were 15 cases of financial exploitation. These cases are more involved than self- neglect.
- Diane reported that there were 7 cases of neglect by others.
- Diane said that she gets reports of abuse from relatives, neighbors and other people.
- Diane informed the board that Adult Protective Services received \$10,544 from the state in 2016 for assistance for people 60 or over who meet the criteria of abuse or neglect. This money can be used for a number of items. Such as: medication, respite, groceries, etc.
- Diane reported that there were 67 different court actions for 28 different people in 2016.
- Diane recommended that everyone have a POA (Power of Attorney).
- Diane said that 6/15 is Elder Abuse Day.
