- 1) The meeting was called to order by David Scribbins at 3:00 p.m.

• GWAAR's Sky Van Rossum was here and talked about transportation solutions. He is in an advisory role and is looking for input on transportation over multiple counties and how counties can coordinate trips. GWAAR received a grant to look into this.
