WHEREAS the Finance Committee has carefully considered these proposed repair projects and is now presenting this Resolution to the County Board for its consideration.

NOW, THEREFORE, BE IT RESOLVED by the Richland County Board of Supervisors that approval is hereby granted for undertaking the following construction projects at the Fairgrounds and the contract for each project is hereby awarded to the following low bidders in the following amounts:

- 1. Show Barn repair project to be undertaken by Berry Construction at a cost of \$7,156.40.
- 2. Roof repair in the Land Conservation Building to be undertaken by Templen Agri-Builders at a cost of \$2,117.06 plus plywood at \$24.00 per sheet, if needed.
- 3. Roof replacement at the A.V. Miller Building to be undertaken by Templen Agri-Builders at a cost of \$5,829.38.
- 4. Junior Dairy Barn roof replacement to be undertaken by Berry Construction at a cost of \$15,848.34, and

BE IT FURTHER RESOLVED that \$30,851.18 is hereby appropriated from the Contingency Fund to the County Fair Fund to carry out this Resolution, and

BE IT FURTHER RESOLVED that this Resolution shall be effective immediately upon its passage and publication.
