ORDINANCE NO. 11 - 6

Amendment # 317 To Richland County Comprehensive Zoning Ordinance No. 5 Relating To The Randall S. Olson Parcel In The Town Of Orion.

The Richland County Board of Supervisors does hereby ordain as follows:

- 1. The County Board, having considered the following factors, hereby finds that the following rezoning is in the best interests of the citizens of Richland County:
 - (a) Adequate public facilities to serve the development are present or will be provided.
 - (b) Provision of these facilities will not be an unreasonable burden to local government.
 - (c) The land to be rezoned is suitable for development and development will not cause unreasonable water or air pollution, soil erosion or adverse effects on rare or irreplaceable natural areas.
 - (d) Non-farm development will be directed to non-agricultural soils or less productive soils.
 - (e) Non-farm development will be directed to areas where it will cause minimum disruption of established farm operations or damage to environmentally sensitive areas.
 - (f) Non-farm development will be encouraged to locate so as to leave a maximum amount of farmland in farmable size parcels.
 - (g) Non-farm residential development will be directed to existing platted subdivisions and sanitary districts.
- 2. Richland County Comprehensive Zoning Ordinance No. 5, which was adopted by the Richland County Board of Supervisors on May 20, 2003, as amended to date, is hereby further amended as follows:

That the official maps designating district boundaries, as adopted by Richland County Ordinance 1985 No. 1 (also known as Amendment No. 1 to the Richland County Comprehensive Zoning Ordinance No. 3), which was adopted on March 19, 1985, are hereby amended as follows:

That the following-described real estate in the Town of Orion is hereby rezoned from the General Agricultural and Forestry District to the Single Family Residential District (R-2):

A part of the Southeast quarter of the Southwest quarter of Section Thirteen, Town 9 North, Range One East, Richland County, Wisconsin, described as commencing 680 feet South of the Northeast corner thereof, thence West 175 feet, thence South 215 feet, thence East 175 feet, thence North 215 feet to the point of commencement.

A part of the Southeast quarter of the Southwest quarter of Section Thirteen, Town Nine North, Range One East, Richland County, Wisconsin, described as commencing at a point that is 895 feet South of the Northeast corner thereof, thence West 150 feet, thence South 150 feet, thence East 150 feet, thence North 150 feet to a point of commencement.

3. This Ordinance shall be effective on March 15, 2011.

No additional compensation shall be paid to full-time County officers or employees for attendance at meetings of the Council. The County Surveyor shall be compensated in accordance with the Surveyor's contract with the County. The Supervisor member shall be paid the standard per diem and mileage for attendance at committee meetings.
- 6. The Council shall review the priorities, needs, policies and expenditures of the Land Information Office and advise the County on matters affecting the Land Information Office, and
