ORDINANCE NO. 11 - 8

Amendment # 318 To Richland County Comprehensive Zoning Ordinance No. 5 Relating To The Dawn Jasper Parcel In The Town Of Westford.

The Richland County Board of Supervisors does hereby ordain as follows:

- 1. The County Board, having considered the following factors, hereby finds that the following rezoning is in the best interests of the citizens of Richland County:
 - (a) Adequate public facilities to serve the development are present or will be provided.
 - (b) Provision of these facilities will not be an unreasonable burden to local government.
 - (c) The land to be rezoned is suitable for development and development will not cause unreasonable water or air pollution, soil erosion or adverse effects on rare or irreplaceable natural areas.
 - (d) Non-farm development will be directed to non-agricultural soils or less productive soils.
 - (e) Non-farm development will be directed to areas where it will cause minimum disruption of established farm operations or damage to environmentally sensitive areas.
 - (f) Non-farm development will be encouraged to locate so as to leave a maximum amount of farmland in farmable size parcels.
 - (g) Non-farm residential development will be directed to existing platted subdivisions and sanitary districts.
- 2. Richland County Comprehensive Zoning Ordinance No. 5, which was adopted by the Richland County Board of Supervisors on May 20, 2003, as amended to date, is hereby further amended as follows:

That the official maps designating district boundaries, as adopted by Richland County Ordinance 1985 No. 1 (also known as Amendment No. 1 to the Richland County Comprehensive Zoning Ordinance No. 3), which was adopted on March 19, 1985, are hereby amended as follows:

That the following-described real estate in the Town of Westford is hereby rezoned from the General Agricultural and Forestry District to the Single Family Residential District (R-2):

Lot #1 of Certified Survey Map #892 as recorded in Volume 8, Certified Survey Maps, at pages 133-134 as Document #293880, Richland County Register of Deeds office.

3. This Ordinance shall be effective on May 17, 2011.

RESOLUTION NO. 11 - 48

A Resolution Opposing Provisions In The Governor's Proposed State Budget For 2012-2013 Relating To Local Government Recycling Programs.

WHEREAS the State's current recycling program includes a requirement that each municipality or county operate a recycling program to manage solid waste in compliance with disposal restrictions and there is a segregated Recycling and Renewable Energy Fund which is funded by a required \$7.00 per ton recycling fee which is collected at the landfill and that Fund is then disbursed in the form of State aid to local government recycling programs, and

WHEREAS this program provides economic development by returning resources to the economy, providing jobs and collecting and processing value feedstock for industries to help them remain competitive, and

WHEREAS the Governor, in his proposed biennial State budget for 2012-2013, has proposed retaining the required \$7.00 per ton recycling fee but eliminating the requirement that municipalities and counties operate a recycling program and eliminating State financial aid for local recycling programs, and

WHEREAS the Solid Waste/Recycling Committee has carefully considered the Governor's proposals and the Committee urges the County Board to join many other municipalities and counties in Wisconsin in expressing opposition to the Governor's proposals and expressing support for a continuation of Wisconsin's recycling infrastructure, by adopting this Resolution.

NOW, THEREFORE, BE IT RESOLVED by the Richland County Board of Supervisors that the County Board hereby expresses its opposition to the proposals in the Governor's proposed State budget for fiscal years 2012-2013 to eliminate the requirement that municipalities and counties operate a recycling program to manage solid waste in compliance with disposal restrictions and also eliminate State financial aid to local governments to operate recycling programs, and

BE IT FURTHER RESOLVED that the County Board hereby expresses support for the continuation of Wisconsin's local government recycling program, and

WHEREAS the Emergency Management Committee has presented a proposal to the Finance and Personnel Committee to establish an on-call pay and a recruitment bonus program for emergency medical technicians, and

Thanksgiving and Christmas, on-call pay of \$15.00 per 12 hour shift. The maximum annual cost of this provision would be \$1,080;

- (b) For weekends from midnight, Friday through midnight, Sunday, on-call pay of \$10.00 per 12 hour shift. The maximum annual cost of this provision would be \$12,480.00;
- (c) Weekdays from 12:00 a.m. Monday through midnight, Friday, on-call pay of \$7.00 per 12 hour shift. The maximum annual cost of this provision would be \$21,840, and
- (d) The maximum annual cost of this on-call pay program would be \$35,400.00, and

BE IT FURTHER RESOLVED that the following recruitment bonus plan is hereby approved:

- (a) \$100.00 to the recruiter for each new applicant to the County's emergency medical technician program who completes 6 months of probation;
