Chairman Greenheck announced the beginning of the Public Hearing for the Community Development Block Grant For Economic Development (CDBG-ED) – Schreiber Foods, Inc. Edward L. White, Economic Development Program Manager for the Southwestern Wisconsin Regional Planning Commission explained the grant. A \$500,000.00 forgivable loan will be extended to Schreiber Foods, Inc. to purchase equipment. In addition, Dean Foods will invest an additional \$20 million to purchase new equipment in Richland Center. The project will result in the creation of approximately 150 full-time positions paying average wages in excess of \$19.00 per hour. Loan payments of principal and interest will be deferred until the forgiveness measurement target date of December 31, 2015. The new full-time positions are to be created by December 31, 2013 and maintained as new full-time positions until December 31, 2015. If the employment target is not met, principal and interest payments will be due based on an amortization schedule. Discussion followed. Chairman Greenheck announced that the Public Hearing was now closed.

ORDINANCE NO. 11-14

Amendment # 321 to Richland County Comprehensive Zoning Ordinance No. 5 Relating To The Kenneth and Alberta Rittenhouse Parcel In The Town Of Akan.

The Richland County Board of Supervisors does hereby ordain as follows:

1. The County Board, having considered the following factors, hereby finds that the following rezoning is in the best interests of the citizens of Richland County:

- (a) Adequate public facilities to serve the development are present or will be provided.
- (b) Provision of these facilities will not be an unreasonable burden to local government.
- (c) The land to be rezoned is suitable for development and development will not cause unreasonable water or air pollution, soil erosion or adverse effects on rare or irreplaceable natural areas.
- (d) Non-farm development will be directed to non-agricultural soils or less productive soils.
- (e) Non-farm development will be directed to areas where it will cause minimum disruption of established farm operations or damage to environmentally sensitive areas.
- (f) Non-farm development will be encouraged to locate so as to leave a maximum amount of farmland in farmable size parcels.
- (g) Non-farm residential development will be directed to existing platted subdivisions and sanitary districts.

2. Richland County Comprehensive Zoning Ordinance No. 5, which was adopted by the Richland County Board of Supervisors on May 20, 2003, as amended to date, is hereby further amended as follows:

That the official maps designating district boundaries, as adopted by Richland County Ordinance 1985 No. 1 (also known as Amendment No. 1 to the Richland County Comprehensive Zoning Ordinance No. 3), which was adopted on March 19, 1985, are hereby amended as follows:

That the following-described real estate in the Town of Akan is hereby rezoned from the General Agricultural and Forestry District to the Agricultural and Residential District:

Lot #1 of Certified Survey Map #907 as recorded in Volume 8, Certified Survey Maps, at pages 157-159, Richland County Register of Deeds.

WHEREAS the Health and Human Services Board has presented these reorganization proposals to the Finance and Personnel Committee and that Committee is now presenting this Resolution to the County Board for its consideration.

NOW, THEREFORE, BE IT RESOLVED by the Richland County Board of Supervisors that approval is hereby granted for the following changes in the organization of the Child Protective Services and the Juvenile Justice functions at the Department of Health and Human Services:

- 1. The non-union position of Children's Services Supervisor at Grade 28 in the County's Job Classification Salary Plan (probationary rate: \$28.33 per hour; after-probation rate: \$29.74 per hour) is eliminated;
- The non-union position of Juvenile Justice Lead Worker at Grade 24 in the County's Job Classification Salary Plan (probationary rate: \$23.41 per hour; after-probation rate: \$24.48 per hour)is created and Ms. Karee Gander, who is currently the Children's Services Supervisor, is named to fill this new position;
- 3. The non-union position of Child Protection Lead Worker at Grade 24 in the County's Job Classification Salary Plan (probationary rate: \$23.41 per hour; after-probation rate: \$24.48 per hour) is created and Ms. Erin Miess, who is currently the most senior certified Social Worker in the Unit, is named to fill this position;
- 4. The current contracted hours for all Child Protective Services/Juvenile Justice certified Social Worker positions increased from 37.5 hours per week to 40 hours per week, with this change affecting 4 certified Social Workers in the Unit, and

BE IT FURTHER RESOLVED that the job descriptions for these new positions, which are attached to the original of this Resolution, are hereby approved, and
