The Richland County Board of Supervisors does hereby ordain as follows:

1. That step 10, paragraph (f) of Richland County Sheriff Department Ordinance No. 89-7, as amended to date, is hereby further amended by adopting the following underlined words and repealing the following crossed-out words:

"(f) All persons who <u>apply for or</u> attain the position of full-time Road Patrol Deputy Sheriff or <u>Task</u> <u>Force Deputy Investigator</u> shall be certified by the State of Wisconsin as a law enforcement officer in accordance with sec. 165.85, Wisconsin Statutes <u>or have completed the law enforcement recruit academy to</u> <u>become eligible for certification prior to the start of their employment.</u> The Department shall give any person who attains the position of full-time Road Patrol Deputy Sheriff or Investigator, and who is not so certified at the time of his or her appointment of the position, opportunity to attend one State of Wisconsin's Certified Police Recruit Academy, where successful completion leads to the full-time Road Patrol Deputy or Investigator being accepted and approved by the State of Wisconsin Law Enforcement Board of Standards. The Department shall be required to provide the time and opportunity to any such person to be required to provide the time and opportunity to any such person to attend such a course only once during their probationary period. Failure to satisfactorily complete the course shall constitute grounds for discharge, except that the Law Enforcement Committee may, in its sole discretion, allow a person who has failed to satisfactorily complete such a course on such terms as the committee deems appropriate."

3. Step 10, (g) is hereby amended by adopting the following underlined words and repealing the following crossed-out words:

"(g) All persons who <u>apply for or</u> attain the position of part-time <u>or casual</u> Road Patrol Deputy Sheriff or Investigator shall be certified by the State of Wisconsin as a law enforcement officer in accordance with that portion of the Wisconsin Statutes which pertains to part-time law enforcement officers sec. 165.85, <u>or have</u> <u>completed the law enforcement recruit academy to become eligible for certification prior to the start of their</u> <u>employment.</u> The Department shall give any part-time Road Patrol Deputy Sheriff who is not so certified at the time of his or her appointment of the position, opportunity to attend one State of Wisconsin's Certified Police Recruit Academy. Where successful completion leads to the full time Road Patrol Deputy or Investigator being accepted and approved by the State of Wisconsin Law Enforcement Board of Standards. The Department shall be required to provide the time and opportunity to any such person to be required to provide the time and opportunity to any such person the recruit school to attend only once. Failure to satisfactorily complete the course shall constitute grounds and cause for discharge, except that the Law Enforcement Committee may, in its sole discretion, allow a person who has failed to satisfactorily complete such a course time and opportunity to retake all or a portion of the course on such terms as the committee deems appropriate."

4. This Ordinance shall be effective immediately upon its passage and publication.
