"County employees receiving leaves of absence for medical reasons must exhaust their sick leave before starting the leave of absence. The County will pay its normal health insurance premium contribution for those employees who are on Worker's Compensation for a period of up to one year and for those employees who are on or a medical leave of absence for a period of up to six months. County employees do not generate vacation and sick leave during unpaid leaves of absence", and
