August 18, 2015

Chairman Kirkpatrick called the meeting to order. Roll call found all members present.

The Invocation was given by Supervisor Seep. County Clerk Vlasak led the Pledge of Allegiance.

County Clerk Vlasak read the agenda for the August session. Motion by Clausius, second by Peters that the agenda be approved. Motion carried.

Chairman Kirkpatrick asked if any member desired that the minutes for the previous session be read or if any member desired to amend the minutes from the previous session. Hearing no motion to read or amend the minutes for the July session, the minutes were declared as approved.

Carrie Leonard, CPA and Audit Partner, Johnson Block & Co., Inc. presented the following highlights of the audit for the year ended December 31, 2014:

- An unmodified opinion was issued on the financial statements of the County;
- The General Fund balance was \$3,454,604 as of December 31, 2014 and represents approximately three months of expenditures;
- Tax certificates totaled \$835,508 in 2014 compared to \$900,458 in 2013;
- County sales tax revenue in 2014 totaled \$1,048,008 in 2014 compared to \$937,788 in 2013;
- \$1,000,000 in state trust fund loans were issued in 2014 to finance Pine Valley design costs;
- Pine Valley recorded a net loss in 2014 of \$563,837 primarily due to changes in the census mix;
- Intergovernmental revenues in 2014 of \$6,627,457 are the largest single revenue source;
- Local property taxes have increased approximately 3.4% over the 2009 level;
- Equalized values have decreased by approximately 2% over an eight year period;
- County sales tax revenues have increase from \$871,351 in 2009 to \$1,048,008 in 2014;
- Health and Human Services and Public Safety expenditures account for 70% of total governmental expenditures;
- Highway operations experienced an operating loss in 2014 of \$94,067.

5. A second payment of \$250.00 would be paid to the new employee after completion of 1 year of employment at Pine Valley, except that an on-call employee must work at least 24 shifts after completing orientation, and

WHEREAS, on the one hand, levy limits do not allow local governments to make up for the deterioration of State funding for local transportation needs while, on the other hand, the State's over- reliance on bonding diminishes the State's segregated funding sources, such as the State gas tax and vehicle registration fees, which are increasingly used to pay debt service rather than to fund local transportation needs, and

WHEREAS the Highway and Transportation Committee is recommending that the County urge the State to provide greater funding for local transportation needs and the Committee is now presenting this Resolution to the County Board for its consideration.

Amendment # 393 To Richland County Comprehensive Zoning Ordinance No. 5 Relating To The David Jacob Parcel In The Town Of Dayton.

The Richland County Board of Supervisors does hereby ordain as follows:

1. The County Board, having considered the following factors, hereby finds that the following rezoning is in the best interests of the citizens of Richland County:

- (a) Adequate public facilities to serve the development are present or will be provided.
- (b) Provision of these facilities will not be an unreasonable burden to local government.
- (c) The land to be rezoned is suitable for development and development will not cause unreasonable water or air pollution, soil erosion or adverse effects on rare or irreplaceable natural areas.
- (d) Non-farm development will be directed to non-agricultural soils or less productive soils.
- (e) Non-farm development will be directed to areas where it will cause minimum disruption of established farm operations or damage to environmentally sensitive areas.
- (f) Non-farm development will be encouraged to locate so as to leave a maximum amount of farmland in farmable size parcels.
- (g) Non-farm residential development will be directed to existing platted subdivisions and sanitary districts.

2. Richland County Comprehensive Zoning Ordinance No. 5, which was adopted by the Richland County Board of Supervisors on May 20, 2003, as amended to date, is hereby further amended as follows:

That the official maps designating district boundaries, as adopted by Richland County Ordinance 1985 No. 1 (also known as Amendment No. 1 to the Richland County Comprehensive Zoning Ordinance No. 3), which was adopted on March 19, 1985, are hereby amended as follows:

That the following-described 4.4 acre parcel belonging to David Jacob in the Town of Dayton is hereby rezoned from the General Agricultural and Forestry District to the Single Family Residential District (R-2):
