Corporation Counsel Southwick explained that the resolution designates the Secretary of the Wisconsin Department of Transportation to run every aspect of the projects. Marc Higgs, Tri-County Regional Airport Manager, explained that \$157,000 per year in grant funds is available. The funds must be petitioned for and specific projects listed. Funding is 90% federal, 5% state and 5% airport. Motion carried and resolution declared adopted.

RESOLUTION NO. 16 - 9

A Resolution Petitioning The Secretary Of Transportation For Airport Improvement Aid.

WHEREAS Richland County, Wisconsin hereinafter referred to as the sponsor, being a municipal body corporate of the State of Wisconsin, is authorized by Wis. Stat. § 114.11, to acquire, establish, construct, own, control, lease, equip, improve, maintain, and operate an airport, and

WHEREAS the sponsor desires to develop or improve the Tri-County Airport, Sauk County, Wisconsin,

"PETITION FOR AIRPORT PROJECT"

WHEREAS airport users have been consulted in formulation of the improvements included in this Resolution, and

WHEREAS a public hearing was held prior to the adoption of this petition in accordance with Wis. Stat. §114.33 (2) as amended, and a transcript of the hearing is transmitted with this petition, and

WHEREAS it is recognized that the improvements petitioned for as listed will be funded individually or collectively as funds are available, with specific project costs to be approved as work is authorized, the proportionate cost of the airport development projects described above which are to be paid by the sponsor to the Secretary of Wisconsin Department of Transportation (hereinafter referred to as the Secretary) to be held in trust for the purposes of the project; any unneeded and unspent balance after the project is completed is to be returned to the sponsor by the Secretary; the sponsor will make available any additional monies that may be found necessary, upon request of the Secretary, to complete the project as described above; the Secretary shall have the right to suspend or discontinue the project at any time additional monies are found to be necessary by the Secretary, and the sponsor does not provide the same; in the event the sponsor unilaterally terminates the project, all reasonable federal and state expenditures related to the project shall be paid by the sponsor; and

WHEREAS the sponsor is required by Wis. Stat. §114.32 (5) to designate the Secretary as its agent to accept, receive for and disburse any funds granted by the United States under the Federal Airport and Airway Improvement Act, and is authorized by law to designate the Secretary as its agent for other purposes.

NOW THEREFORE BE IT RESOLVED by the Richland County Board of Supervisors ("the sponsor") that a petition for federal and (or) state aid in the following form is hereby approved:

The petitioner, desiring to sponsor an airport development project with federal and state aid only, in accordance with the applicable state and federal laws, respectfully represents and states:

- 1. That the airport, which it is desired to develop, should generally conform to the requirements for a general aviation type airport as defined by the Federal Aviation Administration.
- 2. The character, extent, and kind of improvements desired under the project are as follows: replace rotating beacon and tower; conduct wildlife site visit/assessment; reconstruct Runway 9/27, including lighting; reconstruct connecting taxiways; install Runway End Identifier Lights (REILs) on Runway 9; crack fill and sealcoat airport pavements; rehabilitate/upgrade/modify terminal building; and any necessary related work.
- 3. That the airport project, which your petitioner desires to sponsor, is necessary for the following reasons: to meet the existing and future needs of the airport, and

"DESIGNATION OF SECRETARY OF TRANSPORTATION AS SPONSOR'S AGENT", and

BE IT FURTHER RESOLVED by the sponsor that the Secretary is hereby designed as its agent and is requested to agree to act as such, in matters relating to the airport development project described above, and is hereby authorized as its agent to make all arrangements for the development and final acceptance of the completed project whether by contract, agreement, force account or otherwise; and particularly, to accept, receive, receipt for and disburse federal monies or other monies, either public or private for the acquisition,

construction, improvement, maintenance and operation of the airport; and, to acquire property or interests in property by purchase, gift, lease, or eminent domain under Wis. Stat. § 32.02; and, to supervise the work of any engineer, appraiser, negotiator, contractor or other person employed by the Secretary; and, to execute any assurances or other documents required or requested by any agency of the federal government and to comply with all federal and state laws, rules, and regulations relating to airport development projects, and

BE IT FURTHER RESOLVED that the sponsor requests that the Secretary provide, per Wis. Stat. §114.33 (8)(a), that the sponsor may acquire certain parts of the required land or interests in the land that the Secretary shall find necessary to complete the aforesaid project.

"AIRPORT OWNER ASSURANCES", and

BE IT FURTHER RESOLVED that the sponsor agrees to maintain and operate the airport in accordance with certain conditions established in Wis. Admin Code Trans §55, or in accordance with sponsor assurances enumerated in a federal grant agreement, and

BE IT FURTHER RESOLVED that the County Board Chair and the County Clerk be authorized to sign and execute the agency agreement and federal block grant owner assurances authorized by this Resolution, and

- 4. Owners filing after March 1st of the year after the year for which the tax credit is being claimed or not filing at all, are subject, in the discretion of the Land Conservation Committee, to being denied tax credit for the tax year in question.

WHEREAS the roofs on two buildings at the County Fairgrounds are in need of repairs and the Fair/Recycling Committee has solicited bids for this project and the Committee has recommended to the Finance and Personnel Committee that the lowest bid from Templen Agri-Builders, Inc. of Cazenovia in the amount of \$19,020 be accepted, and

WHEREAS Rule 19 of the Rules of the Board requires County Board approval for any building project with a cost of which is \$5,000 or more, and

WHEREAS an appropriation is needed from the Contingency Fund to the County Fair Fund to pay for this project and the Finance and Personnel Committee, having carefully considered this matter, is now presenting this Resolution to the County Board for its consideration.

NOW THEREFORE BE IT RESOLVED by the Richland County Board of Supervisors that approval is hereby granted for a public improvement project consisting of repairing the North end and the South end of the roof on the 4-H building at the County Fairgrounds and repairing, powerwashing and sealing the roof on the sheep barn at the County Fairgrounds, and

BE IT FURTHER RESOLVED that the low bid of Templen Agri-Builders, Inc. of Cazenovia in the amount of \$19,020 is accepted and the contract for this project is awarded to that firm, and

BE IT FURTHER RESOLVED that \$19,020 is hereby transferred from the Contingency Fund to the County Fair Fund for the purpose of carrying out this Resolution, and

BE IT FURTHER RESOLVED that this Resolution shall be effective immediately upon its passage and publication.
