JULY SESSION

July 19, 2016

Chairman Kirkpatrick called the meeting to order. Roll call found all members present except Clausius.

The Invocation was given by Monsignor Roger Scheckel, Pastor of Assumption of St. Mary Parish, Richland Center. County Clerk Vlasak led the Pledge of Allegiance.

County Clerk Vlasak read the agenda for the July session. Motion by Severson, second by Peters that the agenda be approved and the Wednesday mail-out rule set aside so that action can be taken on the resolutions that were not mailed out. Motion carried.

Chairman Kirkpatrick asked if any member desires the minutes of the previous session to be read or if any member desires to amend the minutes of the previous session. Hearing no motion to read or amend the minutes of the June session, the Chairman declared the minutes as approved.

Plaques were presented to past Board members Jim Lewis, Gaylord Deets, Virginia Wiedenfeld and Tom Crofton in appreciation of their years of service on the Richland County Board of Supervisors.

Ben Delzer, CG Schmidt Construction, Assistant Project Manager for the Pine Valley construction project addressed the Board. A drawing was distributed of the construction site showing the progress of the project. The new portion of the building will be substantially completed by September. Pine Valley staff will have a month or so to move in their furniture and equipment and conduct training on the new facility. The first or second week of October residents and staff will be moved into the new building. Renovation of the physical therapy portion of the building has started with the goal to have that area up and running in time for when the residents move. Renovation of the operations part of the existing building will begin later in October and will take approximately four months to complete. Abatement and demolition of the existing bed wing of the building will begin around November 1st and will take approximately two to three months to complete. In the spring the landscaping and parking areas will be finished. The overall project is on budget. The majority of the budget has been committed. \$15,000 to \$40,000 is left in the contingency portion of the budget.

Cathy Cianci, Pine Valley Administrator, reported that the plan is to move eighty residents into the new nursing home on October 6th. The Bureau of Assisted Living is working on the licensing for the assisted living beds. The assisted living will be licensed for the highest level of care that that assisted living can have. It will be a CAN which means three hours of nursing care a week can be provided to those residents. There will be medication administration assistance provided by personal care workers and a RN Manager with a separate licensed administrator. Each resident room is private with its own shower and individual temperature control. Staff has been assigned to the new wings and hiring of staff for the assisted living has started. Many residents have expressed a desire to remain with their current caregivers. Residents are in the process of selecting their new rooms. The residents that have been there the longest are picking their rooms first. The goal is to have one volunteer per resident on move day to accompany the resident into their new room, in-servicing them on their new room and will stay with them until the move is accomplished. The ribbon cutting is tentatively scheduled for September 16th at 9:00 a.m.

Motion by Seep, second by Sebranek that Resolution No. 16-90 be adopted. Chris Glasbrenner, Pine Valley Human Resources Director, explained the reasoning behind the pay structure change. Motion carried and resolution declared adopted.

- 2. Hourly pay for Registered Nurses is upgraded from Grade 22 to Grade 23 in the Plan and Grade 22 is eliminated for Registered Nurses.;
- 3. The above upgrades apply to Licensed Practical Nurses and Registered Nurses at the beginning rate, at the after-18 months rate and at the after-22 months rate, and

BE IT FURTHER RESOLVED that, in accordance with Rule 25 of the Rules of the Board, an emergency exists, as determined by a 3/4ths vote of those Supervisors present, so that this Resolution can be considered by the County Board at other than its August or September sessions, and

BE IT FURTHER RESOLVED that this Resolution shall be effective at the start of the first pay period after August 1, 2016.
