

## **MARCH SESSION**

March 21, 2017

Chairman Kirkpatrick called the meeting to order. Roll call found all members present except Carol Clausius, Dave Turk and Marilyn Marshall.

Monsignor Roger Scheckel, St. Marys of Richland Center, gave the Invocation. County Clerk Vlasak led the Pledge of Allegiance.

County Clerk Vlasak read the agenda for the March session. Motion by Brewer, second by Kinney that the agenda be approved. Motion carried.

Chairman Kirkpatrick asked if any member desires that the minutes of the February session be read or if any member desires to amend the minutes of the previous session. Hearing no motion to read or amend the minutes of the February session, the Chairman declared the minutes as approved.

Resolution No. 17-28 Approving A Contract With The Ho-Chunk Nation To Fund Part Of A Highway Improvement Project To County Trunk Highway Y was read by County Clerk Vlasak. Motion by Brewer, second by Rasmussen that Resolution No. 17-28 be adopted. Highway Commissioner Jim Chitwood explained that the use of the funds from the Tribe is specific to an area of the road. Funds for the improvement project that come from the Highway Department's budget will be spread over a period of three years with completion by the fall of 2020. Commissioner Chitwood introduced Scott Whitsett, Project Manager, Jewell and Associates Engineers, Inc., who has served as a liaison with the Ho-Chunk Nation to secure funding for this project. Motion carried and resolution declared adopted.

### **RESOLUTION NO. 17 - 28**

A Resolution Approving A Contract With The Ho-Chunk Nation To Fund Part Of A Highway Improvement Project To County Trunk Highway Y.

WHEREAS the Highway and Transportation Committee and Highway Commissioner Jim Chitwood are undertaking a highway improvement project for the entire 7.11 mile length of Country Trunk Highway Y, and

WHEREAS the anticipated total cost of this project is over \$2 million, with part of the cost to be paid from Wisconsin Department of Transportation funds, and the Committee is proposing that the County enter into a contract with The Ho-Chunk Nation ("the Tribe") whereby the Tribe would contribute up to \$529,000 to pay 50% of the cost of improving part of the route, and

WHEREAS the Committee now seeks County Board approval for entering into a contract with the Tribe.

NOW THEREFORE BE IT RESOLVED by the Richland County Board of Supervisors that approval is hereby granted for the County to enter into a contract with the Tribe for the purpose of having the Tribe to pay 50% of the cost, not to exceed \$529,000, of improving part of the 7.11 miles of County Trunk Highway Y which is to be improved, and

BE IT FURTHER RESOLVED that the County Highway Commissioner Jim Chitwood is hereby authorized to sign County Cooperative Agreement Number 2-2017 on behalf of the County with the Tribe after this proposed Agreement has been reviewed by Corporation Counsel Ben Southwick and approved by the Highway and Transportation Committee, and

BE IT FURTHER RESOLVED that this Resolution shall be effective immediately upon its passage and publication.

Resolution No. 17-30 Approving Borrowing \$200,000 From The Board Of Commissioners Of Public Lands For The Purchase Of A Sand Pit For The County Highway Department was read by County Clerk Vlasak. Motion by Rasmussen, second by Kinney that Resolution No. 17-30 be adopted. The resolution authorized borrowing from the Trust Funds of the State of Wisconsin the sum of Two Hundred Thousand and 00/100 dollars (\$200,000.00) for the purpose of financing the purchase of real estate for a Highway Department sand pit. The loan is to be payable within 3 years from the 15<sup>th</sup> day of March preceding the date the loan is made. The loan will be repaid in annual installments with interest at the rate of 3.00 per cent per annum from the date of making the loan to the 15<sup>th</sup> day of March next and thereafter annually. Questions were raised regarding the borrowing process and the level of future tax levies for the Highway Department. Chairman Kirkpatrick explained that one reason for the borrowing is to take the pressure off of the County's cash flow. It was noted that the Highway Department was given prior authority to purchase the land using available funds within the department. A three fourths vote of members elect is necessary for approval of the borrowing. Roll call vote. AYES: Bellman, Gentes, Williams, Williamson, Rasmussen, Sebranek, B. Marshall, Jr., Kirkpatrick, Huffman, Seep, McKee, Kinney, Jewell, Peters. NOES: Clary, Severson, Myers, Brewer. Ayes 14. Noes 4. Total 18. Motion declared defeated.

Chris Glasbrenner, Pine Valley Human Resources Director, presented the annual report on the status of the Pine Valley Corporate Compliance Plan. The seven areas focused on included: Quality of Care; Resident Rights; Submission of Accurate Claims; Anti-Kickback Statute/Starks Law; Office of Inspector General Screening and Human Resources Issues: HIPAA and Resident Privacy; and Survey/Certification. The annual survey was conducted and the facility was deficiency free. The facility is 5 star rated.

Joan Bailey, Pine Valley Administrative Assistant, presented the unaudited financial statements as of December 31, 2016. The move into the new facility occurred November 2, 2016. The move was one month later than anticipated resulting in a loss of Medicare revenues because admissions had to be declined during the period. 2016 revenues from all sources totaled \$6,735,062.00. Operating expenses totaled \$7,954,646. The loss from operations was \$1,219,583.00. The loss was offset by tax levy dollars of \$243,689.00 and supplemental payments totaling \$860,900.00. Supplemental payments are funds awarded to governmental facilities that incur an operating loss. Pine Valley's net operating loss for 2016 was \$112,994.00.

Supervisor Clary, Pine Valley Trustee Chair, reported that the abatement of the asbestos and lead from the old facility is continuing. Demolition of the old facility will begin the second week of April once the abatement is completed. Once the demolition of the old facility is completed, the visitor parking area will be completed. Renovation of the part of the old facility that is being kept is almost completed. The total project estimated completion date is July 1<sup>st</sup>.

Chelsea Wunnicke, Family Living Agent, and Adam Hady, Agriculture Agent, distributed copies of a report on the UW-Extension 2016 year in review and reported on the activities they were involved with.

Resolution No. 17-31 Approving The Purchase Of A New SUV Squad Vehicle For The Sheriff's Department was read by County Clerk Vlasak. Motion by McKee, second Seep that Resolution No. 17-31 be adopted. Motion by Clary, second by Peters that the resolution be amended to state that the purchase shall "be paid for from the New Car Outlay Account" and that the "sale proceeds shall be deposited in the New Car Outlay Account". Motion carried on the amended. Motion carried and resolution, as amended, declared adopted.

A Resolution Approving The Purchase Of A New SUV Squad Vehicle For The Sheriff’s Department.

WHEREAS the Law Enforcement and Judiciary Committee and Sheriff Jim Bindl have solicited bids for the purchase of a new SUV squad vehicle for the Sheriff’s Department, and

WHEREAS the Committee wants to purchase the new squad vehicle from the lowest bidder and the Committee is now presenting this Resolution to the County Board for its consideration, and

WHEREAS Rule 19 of the Rules of the Board requires County Board approval for any purchase in excess of \$5,000.

NOW THEREFORE BE IT RESOLVED by the Richland County Board of Supervisors that approval is hereby granted for the Law Enforcement and Judiciary Committee and Sheriff Jim Bindl to purchase a new 2017 Ford Explorer SUV squad vehicle from Fillback Ford Richland Center for a purchase price of \$27,914.28, to be paid for from the New Car Outlay Account, and

BE IT FURTHER RESOLVED that approval is hereby granted for \$3,100 to be spent from the New Car Outlay Account in the Sheriff’s Department’s account in the 2017 County budget to pay for the equipment changeover costs from the squad vehicle that will be traded in for the new squad vehicle, and

BE IT FURTHER RESOLVED that approval is hereby granted for the Law Enforcement and Judiciary Committee to sell the 2014 Ford SUV squad vehicle, which has 168,000 miles on it and which the new vehicle will replace, using an online auction service selected by the Law Enforcement and Judiciary Committee, and the sale proceeds shall be deposited in the New Car Outlay Account, and

BE IT FURTHER RESOLVED that this Resolution shall be effective immediately upon its passage and publication.

WHEREAS there is currently no dedicated, stable State funding source to assist local public health departments to deal with the ever-present threat of communicable diseases, and

WHEREAS the Health and Human Services Board has carefully considered this matter and now is presenting this Resolution to the County Board for its consideration.

NOW THEREFORE BE IT RESOLVED that Governor Walker and the Wisconsin Legislature are

hereby urged to support the creation of a permanent, dedicated fund in the amount of \$2.5 million per fiscal year, for a total of \$5 million over the biennium in the next State budget for the purpose of providing financial assistance to local health departments in order that they will have sufficient staff and resources to support effective infectious disease prevention efforts, and

BE IT FURTHER RESOLVED that the County Clerk shall send a copy of this Resolution to Governor Scott Walker, to the Secretary of the Department of Health Services, to all State legislators whose districts include any part of Richland County and to the Wisconsin Counties Association, and

Health and Human Services is required to have a Medical Director who will provide psychiatric services in order to maintain State certifications for the Mental Health Outpatient Clinic, Crisis Services, and Comprehensive Community Services Program, and

Ordinance No. 17-3 Amendment No. 425 To Richland County Comprehensive Zoning Ordinance No. 5 Relating To The Mary Stadele Estate Parcel In The Town Of Eagle was presented to the Board. Motion by Williamson, second by Sebranek that Ordinance No. 17-3 be adopted. Zoning Administrator Mike Bindl explained the rezoning request. Motion carried and ordinance declared enacted.

### **ORDINANCE NO. 17 - 3**

Amendment No. 425 To Richland County Comprehensive Zoning Ordinance No. 5 Relating To The Mary Stadele Estate Parcel In The Town Of Eagle.

The Richland County Board of Supervisors does hereby ordain as follows:

1. The County Board, having considered the following factors, hereby finds that the following rezoning is in the best interests of the citizens of Richland County:

- (a) Adequate public facilities to serve the development are present or will be provided.
- (b) Provision of these facilities will not be an unreasonable burden to local government.
- (c) The land to be rezoned is suitable for development and development will not cause unreasonable water or air pollution, soil erosion or adverse effects on rare or irreplaceable natural areas.
- (d) Non-farm development will be directed to non-agricultural soils or less productive soils.
- (e) Non-farm development will be directed to areas where it will cause minimum disruption of established farm operations or damage to environmentally sensitive areas.
- (f) Non-farm development will be encouraged to locate so as to leave a maximum amount of farmland in farmable size parcels.
- (g) Non-farm residential development will be directed to existing platted subdivisions and sanitary districts.

2. Richland County Comprehensive Zoning Ordinance No. 5, which was adopted by the Richland County Board of Supervisors on May 20, 2003, as amended to date, is hereby further amended as follows:

That the official maps designating district boundaries, as adopted by Richland County Ordinance 1985 No. 1 (also known as Amendment No. 1 to the Richland County Comprehensive Zoning Ordinance No. 3), which was adopted on March 19, 1985, are hereby amended as follows:

That the following-described 2.0 acre parcel belonging to Mary Stadele Estate in the Town of Eagle is hereby rezoned from the General Agricultural and Forestry District to the Single-Family Residential (R-2) District:

Part of the northeast quarter of the northwest quarter and part of the northwest quarter of the northeast quarter all in section 24, Township 9 North, Range 1 West, Town of Eagle, Richland County, Wisconsin, more particularly described as follows:

Commencing at the northwest corner of said section 24;  
 Thence north 89°26'48" east, along the north line of the northwest quarter, 1337.79 feet;  
 Thence south 00°32'57" east, 627.64 feet to a point at the northeast terminus of the existing right-of-way of Stadele Lane and the POINT OF BEGINNING of the lands hereinafter described;  
 Thence south 88°55'47" east, 212.55 feet;  
 Thence north 86°38'34" east, 833.21 feet;  
 Thence south 03°21'26" east, 33.00 feet;

Thence north 86°38'34" east, 340.77 feet;  
 Thence south 74°37'21" east, 102.07 feet;  
 Thence south 22°58'06" west, 187.15 feet;  
 Thence south 80°58'23" west, 370.89 feet;  
 Thence north 00°10'25" east, 204.55 feet;  
 Thence south 86°38'34" west, 833.72 feet;  
 Thence north 88°55'47" west, 213.23 feet to a point at the southeast terminus of the existing right-of-way of Stadele Lane;  
 Thence north 00°32'57" west, along the easterly terminus of the existing right-of-way of Stadele Lane, 66.03 feet to the point of beginning.

4. This Ordinance shall be effective on March 21, 2017.

Ordinance No. 17-4 Amendment No. 426 To Richland County Comprehensive Zoning Ordinance No. 5 Relating To The Mary Webb Parcel In The Town Of Akan was presented to the Board. Motion by Peters, second by Huffman that Ordinance No. 17-4 be enacted. Zoning Administrator Bindl explained the rezoning request. Motion carried and ordinance declared enacted.

**ORDINANCE NO. 17 – 4**

Amendment No. 426 To Richland County Comprehensive Zoning Ordinance No. 5 Relating To The Mary Webb Parcel In The Town Of Akan.

The Richland County Board of Supervisors does hereby ordain as follows:

1. The County Board, having considered the following factors, hereby finds that the following rezoning is in the best interests of the citizens of Richland County:
  - (a) Adequate public facilities to serve the development are present or will be provided.
  - (b) Provision of these facilities will not be an unreasonable burden to local government.
  - (c) The land to be rezoned is suitable for development and development will not cause unreasonable water or air pollution, soil erosion or adverse effects on rare or irreplaceable natural areas.
  - (d) Non-farm development will be directed to non-agricultural soils or less productive soils.
  - (e) Non-farm development will be directed to areas where it will cause minimum disruption of established farm operations or damage to environmentally sensitive areas.
  - (f) Non-farm development will be encouraged to locate so as to leave a maximum amount of farmland in farmable size parcels.
  - (g) Non-farm residential development will be directed to existing platted subdivisions and sanitary districts.

2. Richland County Comprehensive Zoning Ordinance No. 5, which was adopted by the Richland County Board of Supervisors on May 20, 2003, as amended to date, is hereby further amended as follows:

That the official maps designating district boundaries, as adopted by Richland County Ordinance 1985 No. 1 (also known as Amendment No. 1 to the Richland County Comprehensive Zoning Ordinance No. 3), which was adopted on March 19, 1985, are hereby amended as follows:

That the following-described 8.04 acre parcel belonging to Mary Webb in the Town of Akan is hereby rezoned from the General Agricultural and Forestry District to the Agricultural and Residential District:

A part of the Northwest Quarter (NW ¼) of the Northeast Quarter (NE ¼) of Section nine (9), Town Ten (10) North, Range Two (2) West, Richland County, Wisconsin, described as follows:

Beginning at a point on the North side of said forty which is 782.82 feet West of the Northeast Corner of said forty;

Thence South 04°42'18" West 774.30 feet;

Thence South 41°44'18" West 231.50 feet;

Thence South 88° 09' 40" West 216.60 feet to the west side of side forty;

Thence North 01° 27' 00" West 951.69 along said Westside to the Northwest Corner of Said forty;

Thence east along the North side of said forty 458.20 feet to place of beginning.

EXCEPTING THEREFROM THE FOLLOWING DESCRIBED LAND: All the part of the Northwest quarter (NW ¼) of the Northeast (NE ¼) and part of the Northeast quarter (NE ¼) of the Northwest quarter (NW ¼) of Section Nine (9), Town Ten (10) North, Range Two (2) West, Town of Akan, Richland County, Wisconsin, bounded and described as follows:

Commencing at the North Quarter Corner of Section Nine (9);

Thence South 01°27' 00" East along the west line of the Northeast quarter (NE ¼), 263.92 feet to the point of beginning of the parcel hereinafter described;

Thence South 86°35'04" East. 237.71 feet;

Thence North 05°50'00" East, 19.79 feet;

Thence South 84° 59' 11" East 37.55 feet;

Thence South 05° 27' 26" West, 187.11 feet;

Thence South 89° 22' 11" West, 256.48 feet to a point on the centerline of sunset Road;

Thence North 06°04' 09" West, along said centerline, 188.94 feet;

Thence South 86° 35' 04" East, 17.56 feet to the place of beginning.

3. This Ordinance shall be effective on March 21, 2017.
