#### PATROL OFFICER JOB TASK ANALYSIS

# Current

#### ARREST AND DETENTION

- 1. Arrest persons with or without a warrant
- 2. Advise persons of constitutional rights
- 3. Take mentally ill people into protective custody
- 4. Take people incapacitated by alcohol into protective custody.
- 5. Take developmentally disabled people into protective custody.
- 6. Issue a citation or summons to offenders in lieu of custody arrest.
- 7. Explain the nature of criminal offenses to offenders.
- 8. Detain persons not under arrest for brief periods (questioning).
- 9. Request verification of warrants before arrest.

#### SEARCH AND SEIZURE

- 1. Conduct a search based on probable cause.
- 2. Search premises or property incident to an arrest.
- 3. Search premises of property with written/verbal consent.
- 4. Search premises or property with a warrant.
- 5. Perform no-knock searches.
- 6. Conduct "plain view searches".
- 7. Search abandoned vehicles.
- 8. Search unconscious/helpless persons in emergencies (medic-alert).

#### CRIMINAL INVESTIGATIONS

- 1. Complete preliminary and/or follow-up criminal investigation.
- 2. Conduct death investigations.
- 3. Utilize department records to assist in investigations.
- 4. Conduct lineups, photo lineups, and/or show ups.
- 5. Locate persons using information sources such as utility companies, schools, post office, and other sources available.
- 6. Locate witnesses to crimes or accidents.
- 7. Conduct intelligence activities on known or suspected offenders.
- 8. Interview complainants, witnesses, drivers, etc.
- 9. Conduct surveillance of individuals or locations.
- 10. Exchange information with other law enforcement officers.
- 11. Interrogate/Interview suspects.
- 12. Review crime lab reports to assist in investigations.
- 13. Recruit confidential informants.
- 14. Verify reliability and credibility of witnesses.
- 15 Obtain search or arrest warrants.

## CRIMINAL INVESTIGATIONS (con't.)

- 16. Investigate child abuse complaints/cases.
- 17. Protect crime scene.
- 18. Investigate & enforce domestic, harassment and abuse restraining.

## EVIDENCE COLLECTION AND PRESERVATION

- 1. Secure and search crime scenes, accident scenes and disaster scenes.
- 2. Evaluate the need for specialized assistance at a crime scene.
- 3. Assist/coordinate large scale area searches.
- 4. Fingerprint and photograph people.
- 5. Witness autopsies for evidence documentation.
- 6. Collect, retrieve, package and transport property or evidence.
- 7. Sketch/photograph/document crime scenes, accident scenes or incidents.
- 8. Recover and inventory stolen or found property.
- 9. Document the chain of custody for evidence.
- 10. Inspect vehicle/property for fresh damage (e.g. H&R accident).

#### PATROL OPERATIONS

- 1. Respond to and verify circumstances on 911 disconnects received by the 911 center.
- 2. Stop vehicles to investigate, cite or arrest occupants.
- 3. Observe businesses and dwellings for illegal entry.
- 4. Coordinate actions and responses of other officers as back-ups.
- 5. Secure vehicles (after arrest, accident or abandoned).
- 6. Identify and investigate suspicious vehicles/persons/situations.
- 7. Search buildings or dwellings for criminals, criminal activity or suspicious situations.
- 8. Respond to alarm incidents (e.g. bank alarm, hold-up alarm, burglary alarms, unknown circumstances).
- 9. Physically examine and test doors and windows for security in businesses.
- 10. Physically examine and test doors and windows for security in vacation dwellings.
- 11. Issue warnings or citations to offenders in lieu of a custody arrest.
- 12. Identify specific problems in the city and recommend directed patrol activity to address those problems.
- 13. Identify and report specific problems with streets (e.g. water main break, street lights out, pot holes, ice conditions, etc.).

# NON-ROUTINE SITUATIONS

- 1. Respond to and stabilize hostage situations.
- 2. Participate in raids, search and arrest warrants.
- 3. Evacuate persons from dangerous situations (e.g. bomb threat, gas leak, building fire).
- 4. Provide security and assistance at disaster/unusual occurrences.
- 5. Transport persons not under arrest and in need of assistance (Use of police vehicle)
- 6. Advise citizens or officials of potentially hazardous conditions
- (e.g. leaking gas main, barricaded person with gun, etc).

# 1ST SHIFT, DAY SHIFT (7am to 4:30pm) ROAD PATROL RESPONSIBILITIES

  - c. document unsuccessful attempts at civil process and court documents in the same

#### 2ND SHIFT, EVENING SHIFT (2:30pm to 12 midnight) ROAD PATROL RESPONSIBILITIES

  - b. complaints assigned that are life threatening
  - c. requests for police assistance from the public and from other police agencies.
  - d. non-emergency, non-injury traffic accidents and follow-up
  - e. non-emergency regular complaints assigned by dispatch and follow-up investigations
- 2. "Keeping the Peace" function
  - a. make criminal, warrant and misdemeanor arrests of violators

  - c. document unsuccessful attempts at civil process and court documents in the same manner as "b" above.
  - d. Report an irregularities or special circumstances regarding any civil process or service of court documents to the Sheriff, Chief Deputy or Lieutenant
  - e. provide security for the courts as needed
  - f. transport prisoners to and from Richland County Court or to and from any facility ordered by the court.
  - g. transport prisoners held in other jails for appearances in Richland County court picked up on warrants.
- 5. Security Patrol (Checking doors and property)
  - a. patrol businesses located in the County
  - b. patrol residential areas located in the County
  - c. patrol farm/rural areas located in the County
  - d. monitor and stop traffic that is suspicious in their actions
  - e. provide security to the Courthouse, Sheriff's Dept. and Jail during your shift. check all suspicious activity

# SHIFT, EVENING SHIFT (2:30pm to 12 midnight) ROAD PATROL RESPONSIBILITES

  - a. dispatching or jailing in emergency situations or assisting the jail staff when needed
  - b. posting "no parking" signs
  - c. transports to Passages

# 3RD SHIFT (10:30 p.m. to 8:00 a.m.) ROAD PATROL RESPONSIBILITIES

  - c. requests for police assistance from the public and from other police agencies
  - d. non-emergency, non-injury traffic accidents and follow-up
  - e. non-emergency regular complaints assigned and follow-up investigations

  - a. make criminal, warrant and misdemeanor arrests of violators
  - b. provide a "keep the peace" presence at all festivals, fairs, celebrations or gatherings of citizens throughout the County during your shift

    example: speeding, fail to dim headlights, tail-light and headlight malfunctions, 5-days
  - c. other traffic violations -- non life-threatening example: registration expiration, illegal registration, muffler, etc.
- 5. Perform other tasks assigned to you prior to shift or during shift
  - a. building moving assists, usually arranged
  - b. paper service if prior arrangements made or person is hard to serve during the other 2 shifts
  - c. traffic problem areas that have been assigned for you to work due to citizen complaints.
  - d. any other tasks as assigned by the Sheriff, Chief Deputy, Lieutenant or supervisor. (i.e. prisoner transports, posting no parking signs, etc.)
