NOW THEREFORE BE IT RESOLVED by the Richland County Board of Supervisors that approval is hereby granted for the Highway and Transportation Committee and the County Highway Commissioner to purchase a new body-building package to equip a new tri-axle truck from Universal Truck Equipment of Galesville, Wisconsin, and

BE IT FURTHER RESOLVED that the \$76,855.00 cost of this purchase is in the Machinery Fund of the Richland County Highway Department's account in the 2017 County budget, and

Resolution No. 17-27 Changing The Alcohol And Drug Abuse Counselor (Certified) Position At The Department Of Health And Human Services was read by County Clerk Vlasak. The pay grade will be determined based upon the level of certification that the person has who is hired to fill the position. If the applicant for the position is a Certified Substance Abuse Counselor or Certified Substance Abuse Supervisor in training, the hourly rate shall be at non-union grade # 22 (probationary rate: \$21.91; after probation rate: \$22.97);

If the applicant is a Certified Substance Abuse Counselor Intermediate Clinical Supervisor, the hourly rate shall be at non-union grade # 24 (probationary rate: \$24.06; after probation rate: \$25.23);

If the applicant is a Certified Substance Abuse Counselor Independent Clinical Supervisor, the hourly rate shall be at non-union grade # 26 (probation rate: \$26.45; after probation rate: \$27.72), and

BE IT FURTHER RESOLVED that the job description for the Certified Substance Abuse Counselor (CSAC) position which is on file in the County Clerk's office is hereby approved, and

Ordinance No. 17-2 Amendment No. 424 To Richland County Comprehensive Zoning Ordinance No. 5 Relating To The Joseph And Debra Mueller Parcel In The Town Of Dayton was presented to the Board. Motion by Sebranek, second by Kinney that Ordinance No. 17-2 be enacted. Zoning Administrator Mike Bindl explained that the parcel was created after zoning and is an illegal parcel. The rezoning is being requested to allow for the construction of a home. Motion carried and ordinance declared enacted.

## **ORDINANCE NO. 17 - 2**

Amendment No. 424 To Richland County Comprehensive Zoning Ordinance No. 5 Relating To The Joseph And Debra Mueller Parcel In The Town Of Dayton.

The Richland County Board of Supervisors does hereby ordain as follows:

1. The County Board, having considered the following factors, hereby finds that the following rezoning is in the best interests of the citizens of Richland County:

- (a) Adequate public facilities to serve the development are present or will be provided.
- (b) Provision of these facilities will not be an unreasonable burden to local government.
- (c) The land to be rezoned is suitable for development and development will not cause unreasonable water or air pollution, soil erosion or adverse effects on rare or irreplaceable natural areas.
- (d) Non-farm development will be directed to non-agricultural soils or less productive soils.
- (e) Non-farm development will be directed to areas where it will cause minimum disruption of established farm operations or damage to environmentally sensitive areas.
- (f) Non-farm development will be encouraged to locate so as to leave a maximum amount of farmland in farmable size parcels.
- (g) Non-farm residential development will be directed to existing platted subdivisions and sanitary districts.

2. Richland County Comprehensive Zoning Ordinance No. 5, which was adopted by the Richland County Board of Supervisors on May 20, 2003, as amended to date, is hereby further amended as follows:

That the official maps designating district boundaries, as adopted by Richland County Ordinance 1985 No. 1 (also known as Amendment No. 1 to the Richland County Comprehensive Zoning Ordinance No. 3), which was adopted on March 19, 1985, are hereby amended as follows:

That the following-described 20 acre parcel belonging to Joseph and Debra Mueller in the Town of Dayton is hereby rezoned from the General Agricultural and Forestry District to the Agricultural and Residential District:

Part of the North 1/3 of the Northwest ¼ of the Southeast ¼ of Section 9; the South 66 feet of the North 1/3 of the Northeast ¼ of the Southeast ¼ of Section 9; that portion of the South 66 feet of the North 1/3 of the Northwest ¼ of the Southwest ¼ of Section 10 lying West of the centerline of the Town Road; all in Township 10 North, Range 1 West, Richland County, Wisconsin.

3. This parcel shall not be divided again without approval by the Zoning and Land Information Committee.

4. This Ordinance shall be effective on February 21, 2017.

Chairman Kirkpatrick announced that having received the advice of the Committee on Committees and subject to confirmation by the County Board she is appointing Kerry Severson to the Health and Human Services Board for the remainder of Bob Bellman's term which expires April, 2018. Supervisor Bellman had resigned from the Health and Human Services Board effective January 21, 2017. Motion by Peters, second by Seep to confirm the appointment. Motion carried.

Supervisor Clary, Chairman of the Pine Valley New Facility Temporary Construction Oversight Committee, reported that the abatement of the old skilled facility started a couple of weeks ago. Removal of any asbestos and lead from that section of the building is scheduled for completion by the end of March. Once abatement is completed, demolition of that section of the building will begin. The Pine Valley construction project is proceeding on schedule and is slightly under budget.

Zoning Administrator Bindl reported the receipt of a rezoning petition from the Mary Stadele Estate and Lawrence Stadele to rezone 2.0 acres from Agricultural-Forestry to Residential-2 in the Town of Eagle and a petition from Mary Webb to rezone 8.04 acres from Agricultural-Forestry to Agricultural-Residential in the Town of Akan. Chairman Kirkpatrick referred the petitions to the Zoning and Land Information Committee for action.

Zoning Administrator Bindl reported that there were no rezoning petitions being recommended for denial by the Zoning and Land Information Committee.

Chairman Kirkpatrick read correspondence received from Darlene Dice expressing appreciation for the recognition received upon her retirement from the County Board for her years of service at Pine Valley and correspondence received from Milann Thiede expressing appreciation for having been awarded a scholarship from the Fred and Hazel Pauls Scholarship Fund.

Motion by Bellman, second by Williams to adjourn to Tuesday, March 21, 2017 at 10:00 a.m. Motion carried.
