 Thence north 00°05'25" west, along said west line, 1038.12 feet to the point of beginning.

Zoning Administrator Bindl reported the receipt of a rezoning petition from John, Susan and Wyatt Seep to rezone 5.57 acres in the Town of Westford from Agricultural-Forestry to Agricultural-Residential and a petition from Kevin Schmitz to rezone 2.5 acres in the Town of Buena Vista from Agricultural-Forestry to Residential-1. Chairman Kirkpatrick referred the petitions to the Zoning and Land Information Committee for action.

Health and Human Services Director Patrick Metz presented information regarding services provided and clients served by the agency and the utilization of the tax levy. The regional Aging and Disability Resource Centers are state and federally funded. ADRC funds help to support overhead costs within the agency. The 2016 levy was reprioritized to focus on placement costs. Fourteen positions and eight leased positions remain unfilled in the agency as a result of attempts to be fiscally responsible. The Mental Health Therapist, Substance Abuse Counselor and Psychiatry positions are vacant. Myranda Culver, Supervisor for Counseling and Clinical Services at Health and Human Services reviewed the services provided by CCS. Cindy Hanold, Chief Nursing Officer at the Richland Hospital explained the intake issues the hospital is experiencing regarding people who are not having their mental health needs met. Diane Cox, Adult Protective Services Social Worker at Health and Human Services addressed the Board regarding mental health issues in the community. Ms. Cox also works for Northwest Connections who provide emergency mental health services to contracted counties in Wisconsin.

Chairman Kirkpatrick noted that copies of the 2016 Financial Report of Highway Operations were distributed to Board members.

Troy Maggied, Executive Director of Southwestern Wisconsin Regional Planning Commission, provided information on the services provided to Richland County by the staff of the Commission. Kate Koziol, Economic Development Specialist, was introduced. Ms. Koziol will be providing economic development services to the county as a result of funding from Southwest Partners, Inc. for a 20% position contracted with the Southwest Regional Planning Commission.

Motion by Huffman, second by Bellman that Resolution No. 17-59 be adopted. Chairman Kirkpatrick explained that this has been an unfunded mandate. Motion carried and resolution declared adopted.

RESOLUTION NO. 17 - 59

A Resolution Amending The County's Handbook Of Personnel Policies And Work Rules Relating To Payment For Accumulated Sick Leave.

WHEREAS the County Board has adopted a comprehensive list of all aspects of County employment entitled the Handbook of Personnel Policies and Work Rules and it is necessary for the County Board to amend the Handbook from time to time to meet the ever-changing needs of County government, and

WHEREAS the Finance and Personnel Committee has carefully considered a proposal to amend the provisions of the Handbook of Personnel Policies relating to payment for accrued sick leave and the Committee is now presenting this Resolution to the County Board for its consideration.

NOW THEREFORE BE IT RESOLVED that the following amendments to paragraph 10 under the heading entitled "Sick Leave" in the section entitled "COMPENSATION AND FRINGE BENEFITS" are hereby approved by adopting the following underlined language:

"The following 3 paragraphs apply only to employees who were hired by Richland County prior to January 1, 2018. (This benefit is not available to employees hired after December 31, 2017):

All accrued sick leave is lost when employment ceases, including when the individual is appointed to, or elected by the voters, to a full-time elected County position; exceptions are death, retirement or early retirement.

Any unused sick leave accumulated by the employee to a maximum of sixty (60) days at the time of death or retirement shall be paid to the employee in a lump sum upon death or retirement, provided that upon retirement the employee is eligible for retirement benefits under the Wisconsin Retirement Fund. In lieu of payment each such employee shall be offered the option of converting 90% of his/her eligible accumulated sick leave (up to 126 days) to payment toward health insurance premium. The employee election provided in

this paragraph shall be in writing and shall be submitted to the County Clerk. The employee may not change his/her election once it has been submitted.

Except as otherwise authorized in special circumstances, a Department Head shall leave a position vacant for such period of time as is necessary to recoup the cost of providing the benefit described in the preceding paragraph.

The following paragraph applies to employees who were hired by Richland County after December 31, 2017:

All accrued sick leave is lost when employment ceases, including when the individual is appointed to, or elected by the voters, to a full-time elected County position. Accrued but unused sick leave is not paid to employees when employment ceases, and

BE IT FURTHER RESOLVED that this Resolution shall be effective immediately upon its passage and publication.

Health and Human Services Director Patrick Metz estimates the savings from the layoff days to be between \$25,000 and \$30,000. Metz noted that not all employees in the department are supported by tax levy dollars. The Capital Consortium has concerns because the action to close the agency on those days is potentially in violation of the contract. The Consortium will have to figure out how to cover for the 14 people who answer the phones and provide the lobby services. Lobby services would be available in the other counties in the Consortium. Metz explained that staff appreciate that the layoff days are wrapped around a holiday. Having the doors closed to the agency on the proposed days helps the community see that the agency is trying to do something to address the financial issues. Motion carried and resolution declared adopted.

ORDINANCE NO. 17 - 10

An Ordinance Establishing A Slow-No-Wake Zone On The Pine River In Richland County.

The Richland County Board of Supervisors does hereby ordain as follows:

1. This Ordinance is authorized by Wisconsin Statutes, section 30.77 (3) (b).
2. The County Board is enacting this Ordinance in the interest of public health, safety and welfare, including the public's interest in preserving the State's natural resources.
3. "Motorboat" means any boat equipped with propulsion machinery, whether or not the machinery is the principal source of propulsion.
4. "Personal watercraft" means a motorboat that uses an inboard motor powering a water jet pump or a caged propeller as its primary source of motive power and that is designed to be operated by a person standing on, kneeling on or sitting astride the watercraft.
5. "Operate" is to navigate or otherwise employ a motorboat or a personal watercraft.
6. "Slow-no-wake" means that speed at which a boat moves as slowly as possible while still maintaining steerage control.
7. The entire length of the Pine River lying within Richland County is designated as a slow-no-wake zone.
8. No person shall operate a motorboat or personal watercraft in the slow-no-wake zone designated herein at a speed faster than that speed at which a boat or personal watercraft moves as slowly as possible while still maintaining steerage control.
9. The Ordinance shall not apply to training exercises by police, fire and ambulance emergency services.
10. Any person who shall violate this Ordinance shall, upon conviction thereof, forfeit to Richland County not less than \$100.00 nor more than \$400.00 plus applicable costs, fees and surcharges imposed under Wisconsin Statutes, Chapter 814 and, in the event such forfeiture, costs, fees and surcharges are not paid, such person, upon order of the Circuit Court of Richland County, shall be imprisoned in the Richland County Jail until such forfeiture, costs and assessments are paid, but not to exceed 90 days, or may be subject to other sanctions lawfully imposed by the Court for such failure to pay.
11. This Ordinance shall be enforced by the Sheriff of Richland County. Violations of this Ordinance shall be prosecuted by the Corporation Counsel of Richland County.
12. This Ordinance shall be effective immediately upon its passage and publication.

Rules and Resolutions Committee Chairman Clary reported that the Committee met and discussed a request from a County Board Supervisor to amend the Rules of the Board to suspend the payment of per diem and mileage to Supervisors for the remainder of 2017 for attendance at sessions of the County Board and meetings of boards or committees. Clary noted that it was not clear if the request was to include citizens members. The request did not pass in the Rules and Resolutions Committee meeting. Clary noted that Supervisors do have the option to reject per diem and mileage payments. Corporation Counsel Southwick reported that he is working with the Supervisor who made the request to draft a resolution to suspend the Rules of the Board regarding the payment of per diem and mileage.

Pine Valley Trustees Chairman Clary reported that the demolition of the old nursing home is three to four weeks behind schedule because at the Construction Committee's request, the cement from the demolition is being separated so that it can be used for parking lot fill. The total construction project is under budget. The project is about thirty days behind schedule.
