

**RESOLUTION NO. 20 - \_\_\_\_\_**

A Resolution Approving The Purchase Of 3 Cardiac Monitors For The Ambulance Service.

WHEREAS the Joint Ambulance Committee has 3 cardiac monitors all of which will be at the end of their useful life with no technical support at the end of 2021, and

WHEREAS, while the Joint Ambulance Committee has budgeted for the replacement of only 2 monitors in 2021, a manufacturer of these monitors, Stryker Medical Corporation of Chicago, is offering a finance option of installment payments over 3 years at no interest if the purchase is made in December, 2020, and

WHEREAS the Joint Ambulance Committee and the Ambulance Service Director, Darin Gudgeon, have recommended to the Finance and Personnel Committee that the firm's proposal be accepted and the Committee is now presenting this Resolution to the County Board for its consideration.

NOW THEREFORE BE IT RESOLVED by the Richland County Board of Supervisors that approval is hereby granted for the Joint Ambulance Committee to purchase 3 new cardiac monitors from Stryker Medical Corporation at a cost of \$101,521.64 and the Committee shall make this purchase in December, 2020 in order to take advantage of the firm's proposal to allow installment payments over 3 years at no interest, and

BE IT FURTHER RESOLVED that the total price of \$101,521.64 is to be paid as follows:

1. \$5,000 upon the placement of the order;
2. Six semi-annual payments of \$16,086.94, with the first payment due within 30 days of placing the order, and

BE IT FURTHER RESOLVED that approval is hereby granted for trading in 3 Philips XL cardiac monitors as part of this transaction, and

BE IT FURTHER RESOLVED that the following entities will pay the following amount of the purchase price:

1. \$2,604.31 from the Richland County Ambulance Association;
2. \$2,395.69 from the State Funding Assistance Program, leaving a net cost to the County of \$96,521.64, and

BE IT FURTHER RESOLVED that the County Administrator is hereby authorized to sign on behalf of the County any documents necessary to carry out this Resolution, and

BE IT FURTHER RESOLVED that this Resolution shall be effective immediately upon its passage and publication.
