Minutes Transportation Coordinating Committee Wednesday, February 10, 2021

A Public Hearing and regularly scheduled meeting of the Transportation Coordinating Committee was held Wednesday, February 10, 2021 at 3:00 p.m. via ZOOM.

Committee members in attendance included: David Scribbins, Sandra Kramer, Aaron Gray, Sandra McKittrick, Ingrid Glasbrenner and Bob Sheire

Members absent: Richard McKee and Darren Steinmetz

Other attendees include Linda Batten, Roxanne Klubertanz-Gerber, Heidi Sheire, Cole Pyferon and Chris Knable

- 1) The meeting was called to order by David Scribbins at 3:00 p.m.
- 2) Proof of Notification: Linda Batten verified the posting.
- 3) Approve Agenda:
 - Bob Sheire moved to approve the posting and agenda; Sandra McKittrick seconded. Motion carried.
- 4) Approval of October 14, 2020 Transportation Coordinating Committee minutes:
 - Bob Sheire moved to approve minutes; Ingrid Glasbrenner seconded. Motion carried.
- 5) Review and Approve new committee member request:
 - Roxanne explained to the board that Eric Rynes resigned from Schmitt and the board.
 - Roxanne said that Cole Pyferon sent a letter of interest to be on the board.
 - Roxanne asked the board for a motion to approve Cole Pyferon to The Transportation Coordinating Committee.
 - Sandra Kramer moved to approve Cole Pyferon as the new member of the Transportation Coordinating Committee. Bob Sheire seconded. Motion carried.
- 6) Review and Approve 2020 program ridership:
 - Roxanne told the board that in the first few months of the pandemic we were only transporting people for dialysis and cancer.
 - Roxanne reported to the board that in 2019 the driver escort program (volunteers) did 4916 oneway trips and that in 2020 that number was 3421 one-way trips.
 - Roxanne also reported that the bus program in 2019 did 1298 one-way trips. In 2020, that number was down to 436 one-way trips. There were no charter trips, only grocery route and bus routes.
 - Roxanne also said safety precautions were in place for both volunteers and buses.
- 7) Report on 2020 Transportation Budget:
 - Roxanne said that the 2020 budget is \$197,733 and there have been \$140,960 in expenses.
 - Roxanne also said that her budget expenses does not match the Business Manager's. So they are going to get together to figure it out.
 - Roxanne further said that if we do not spend all of 85.21 funds, the surplus will have to go into a separate account and we have 3 years to spend the money.

- 8) Report on 2021 Transportation Budget
 - Roxanne reported that there are no concerns with the 2021budget at this point. She said it is early in the year but she expects that we will be on budget.
- 9) Updates from Transportation Providers:
 - Nothing
- 10) Citizen Comments:
 - Pine Valley is doing COVID testing of residents and our drivers.
 - Roxanne reported that we salvaged a couple of vehicles that were retired due to their poor condition.
 - Roxanne said our building is closed and if any drivers need anything that Linda will run out and give them paperwork or supplies.
 - Roxanne informed the board that all of the drivers who wanted the COVID vaccinations have received their second vaccination.
 - Roxanne told the board that we are working on the 3 year Aging Plan via the website and she has setup meetings at several apartment buildings. (If we are allowed to have these in person because of COVID.)
 - Cole Pyferon said that Schmitt is going to once a monthly testing.
 - Discussion was held regarding vaccinations being held at the hospital and Thrifty White and Public Health is holding clinics at the Community Center.
 - Bob Sheire said the Red Cross would hold blood donations at the Phoenix Center on three different days in March.
 - Cole Pyferon said that Schmitt is using the bus that they leased.

 - Bob Sheire moved to adjourn the meeting until May 12, 2021; Ingrid Glasbrenner seconded. Motion carried.
