The Committee on Committees met virtually on Monday, May 17, 2021, at 1:00 p.m.

Motion by Cosgrove to approve agenda, seconded by Brewer, and the motion carried.

Murphy-Lopez makes motion to present recommended appointments to the Coordinated Services Team to the Richland County Board of Supervisors, Luck seconds, and the motion carried.

Administrator Langreck reviewed recommended appointments to the Transportation Coordinating Committee as follows:

Appointment of Cole Pyffereon to replace Eric Rynes.  
Appointment of Linda Symons to replace David Scribbins.

Cosgrove makes motion to present recommended appointments to the Transportation Coordinating Committee to the Richland County Board of Supervisors, Luck seconds, and the motion carried.

Administrator Langreck reviewed recommended appointments for Danielle Cooper. Murphy-Lopez makes motion to appoint Cooper to the Parks Commission Committee, Fair and Recycling Committee, Health & Human Services Board, and the Nutrition Advisor Council, Luck seconds, and the discussion continued. Severson makes motion to nominate Steve Williamson to the County Parks Commission, Cosgrove seconds, discussion continued. Brewer noted that attempts are made to even out appointments to committees and that new board members are not often initially appointed to the larger departments. Severson noted that Timothy Gottschall sent communication indicating his interest in being on the Health and Human Services Board. Murphy-Lopez noted the potential for Cooper to be on less committees than average and Luck asked if there were other committees Cooper could be involved in. Luck noted that it may be helpful to have a more experienced board member on the Health and Human Services Board and Murphy-Lopez noted that Gottschall is currently assigned to three committees. Motion to appoint Steve Williamson to the County Parks Commission restated, a vote was taken, and the motion to appoint Steve Williamson to the County Park Commission was defeated. Murphy-Lopez makes motion to amend initial motion to place Cooper on all four committees as initially recommended by removing her appointment from the HHS Board, replacing her proposed HHS appointment with one for Gottschall, and leaving Cooper to serve on the remaining three committees as initially presented, Luck seconds, amended motion carried with Severson opposing. Motion to appoint Cooper to County Parks Commission, Fair & Recycling Committee, and Nutrition Advisory Council and appoint Timothy Gottschall to the Health & Human Services Board carried.

Administrator Langreck reviewed recommended appointments for the Veterans Service Commission.

Appointment of Patrick Metz to replace seat held by James Deitelhoff.

Murphy-Lopez makes motion to present recommended appointments to the Veterans Service Commission to the Richland County Board of Supervisors, Luck seconds, and the motion carried.

Administrator Langreck reviewed recommended appointments for the Hidden Valleys Board. Langreck noted that due to work schedule conflicts he cannot attend the Hidden Valleys meetings and that the Parks Commission is taking action to step away from the Hidden Valleys Board. Severson makes motion to appoint Cooper to the Hidden Valleys Board, Cosgrove seconds, motion carried.

Motion by Murphy-Lopez, second by Cosgrove to adjourn at 1:34 pm. Motion carried.
