  - EDD Glasbrenner reported work efforts in the following categories;
    - Richland Center new commercial buildings being constructed Dialysis Center and Tech Com.
    - ii. Housing efforts In-fill housing plans, new subdivision
    - iii. Work on Comprehensive and Strategic Planning in collaboration with SWRPC. Projects involve Richland County, Richland Center, Lone Rock, with Cazenovia, Yuba, and Boaz beginning in the future. This is part of the USEDA Grant that the county received and will involve projects and involvement by RED for the next two years.
    - iv. Countywide survey being conducted
    - v. CDBG Close Program Lone Rock and Richland Center projects moving to final application stage.
    - vi. Broadband expansion grant letters
    - vii. City and County Securing funds and writing policy for programs.
    - viii. Work with Richland Center Redevelopment Authority to plan for future

- Seven sights were identified. Considerations were discussed.
- Discussion by the RED Board included.
  - i. City Annexation
  - ii. Eminent Domain Legal components of this process need to be understood. Desire to avoid this if at all possible.
  - iii. City is developer or must find and attract a developer
    - 1. We may have to have below market rate lots like other communities are introducing Hillsboro & Shullsburg.
  - iv. To many people are indicating that there is no place to live in Richland Center and are locating in other places Reedsburg.
  - v. The concept of White Tail Trials was discussed for land outside of Richland Center or other villages.
  - vi. The city is probably going to have to contribute to both land and infrastructure.
  - vii. Importance of County Ordinances around land splits.
- 6. Hiring a consultant for administrative work
  - EDD Glasbrenner needs part time assistance –
  - Areas of assistance are needed in communication, email lists, web & FB, projects that are grant focused like Weber Dry-cleaning, reviewing and rewriting manuals that guide RLF & Housing Funds, fund recovery efforts that need to be worked on.
