#### **ORDINANCE NO. 22 - 3**

An Ordinance Repealing Ordinance No. 99 - 11 And Adopting The General Schedules For County Governments As Established By The State Of Wisconsin Public Records Board For Use In The Disposal Of Obsolete County Records.

The Richland County Board of Supervisors does hereby ordain as follows:

- 1. Ordinance 99 11 is out of date and in need of revision; and,
- 2. The State of Wisconsin Public Records Board has created a record retention schedule for use by Wisconsin counties and local governments; and,
- 3. The attached appendix entitled "General Schedule" including Addendums B, C, E, and F is intended to be the only retention schedule dealing with county records to provide both officials, employees, and the general public a single point of reference pertaining to the general records of the county; and,
- 4. The Richland County Board of Supervisors that Ordinance No. 99 11 is hereby repealed and replaced with Ordinance No. 22 3 to read as contained in the attached appendix; and,
- 5. Department heads shall provide the County Administrator and the Rules & Strategic Planning Standing Committee notice of the destruction of any county record(s) and/or transference to the Wisconsin State Historical Society at least 7 days in advance of either action being taken; and,
- 6. Corporation Counsel should be consulted as needed when questions regarding the retention of a county record arise; and,

- 7. In the event the State of Wisconsin Public Records Board amends the General Schedule for County Governments and corresponding Addendums, Ordinance No. 22 - 3 will encompass the amended schedule as set forth therein.
- 8. This ordinance shall effective immediately upon its passage and publication.

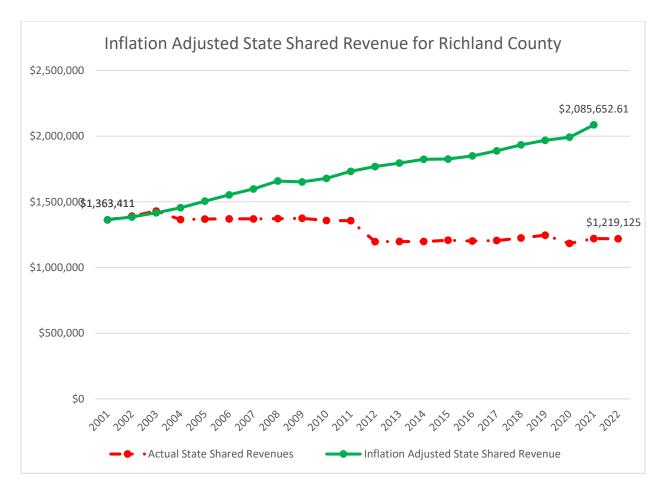
# **RESOLUTION NO. 22 - 71**

A Resolution Imploring The State Of Wisconsin To Increase State Shared Revenues And State Highway Aids For Richland County.

WHEREAS annual state shared revenues from the State of Wisconsin to Richland County have dropped 10% between 2001 and 2021 from \$1.36 million in 2001 to \$1.22 million in 2021, and

WHEREAS, the Consumer Price Index shows that prices increased 43% between 2001 and 2021, and

WHEREAS, if Richland County's state shared revenues had kept pace with inflation, the annual amount of state shared revenue in 2021 would have been \$2.1 million, and

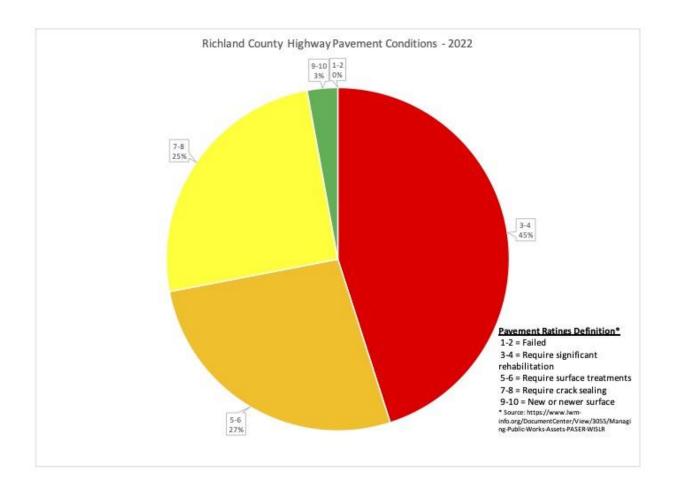


WHEREAS, this decrease in state shared revenues has negatively impacted the budgets of the following three Richland County departments in order of most to least impact: 1) Sheriff, 2) Highway, 3) Health & Human Services, and

WHEREAS, property tax levy limits imposed by the State of Wisconsin on Richland County have restricted our ability to raise property taxes to offset losses in state shared revenues, except for borrowing, and

WHEREAS, in a similar fashion, annual state highway aids to Richland County have dropped 22% between 2001 and 2019 from \$757,000 in 2001 to \$592,000 in 2019, and

WHEREAS, 45% (or 137 out of 304 miles) of all County highways in Richland County are in need of significant rehabilitation because of a lack of maintenance funding, and



WHEREAS, due in part to the State's decrease in state shared revenues and state highway aids, Richland County property owners have seen recent increases in property taxes for borrowing to pay for Sheriff's patrol vehicles, Highway maintenance projects, and Health & Human Services building repairs.

NOW THEREFORE BE IT RESOLVED, Richland County implores the State of Wisconsin to increase its state shared revenues and state highway aids to Richland County, to ensure funding for the Sherriff's, Highway, and Health & Human Services Departments, and

BE IT FURTHER RESOLVED, that a copy of this resolution be sent to Governor Tony Evers, State Senator Howard Marklein, State Assembly Representative Travis Tranel, State Assembly Representative Todd Novak, State Assembly Representative Tony Kurtz, and the Wisconsin Counties Association.

WHEREAS because of these decreases and reorganization by the state, the Richland campus no longer has staff positions of Dean, five Associate Student Services Coordinators, one custodian, 3 Financial specialists, one Library Assistant, one Continuing Education Coordinator, one First Year Initiative Coordinator; and

WHEREAS as of 2015 no new or replaced professors have been hired; and

WHEREAS because of these financial decreases and position losses have influenced the enrollment in traditional college classes and eliminated enrollment for adult and youth Continuing Education; and

NOW, THEREFORE, BE IT RESOLVED, Richland County implores the State of Wisconsin and the UW-System to increase their investment in UWP-Richland and the other 12 UW Colleges, to ensure that a viable educational institute be continued.

THEREFORE, BE IT RESOLVED, that the Richland County Board of Supervisors hereby supports this resolution and that it be sent to the Wisconsin Counties Association, area legislators, Governor, and UW Systems President.

A Resolution Relating To PSAP Grant Funding For One Public Safety Answering Point Per County.

WHEREAS, every municipal and state agency that provides fire suppression, law enforcement, and EMS, may establish a 911 system. Most counties operate their own Public Safety Answering Point (PSAP) to meet the needs of their citizens; and

WHEREAS, the 2017-19 Wisconsin state budget required DMA to create an emergency services IP network to be provided to all PSAPs. This digital network is essential in transitioning the state's 911 system from the old and outdated analog system to a current and advanced NextGeneration 911 system; and

WHEREAS, 2019 Wisconsin Act 26 created a much needed PSAP grant program aimed to provide grant dollars for advanced training of telecommunicators; equipment or software expenses; and incentives to consolidate some or all of the functions of two or more PSAPs; and

WHEREAS, 2019 Wisconsin Act 26 requires that only one PSAP per county receive the grant funds. The county board of supervisors will determine the grant recipient except for Milwaukee County where the Intergovernmental Cooperation Council will make the determination.

WHEREAS, Wis. Admin. Code § DMA 2.03 requires that each county designate a public safety answering point as the "designated public safety answering point" to be eligible to apply for grants in that county.

NOW, THEREFORE, BE IT RESOLVED that Richland County does hereby designate the Richland County Public Safety Answering Point for the purposes of 2019 Wisconsin Act 26 grant dollars or federal grant opportunities.

- c. To Establish expectations for employees volunteering hours in support of fair operations

#### 4. Scope

- a. Applies to all departments working under Richland County.
- b. Applies to department employees whose regular job duties do not already include support of fair operations

#### 5. Policy Overview

- a. The content of this policy includes:
  - i. Employee work hours' consent
  - ii. Department Approval
  - iii. Fair Coordinator Approval and Authority
  - iv. Restrictions and Limitations
  - v. Employee volunteer hours
  - vi. Retained Authority by the County
  - vii. Complaint process

#### 6. Policy Performance

a. The policy is intended to fill no less than (80 hour) shift/slots with county employee staff support from other county departments

#### **Policy Content**

#### 7. Employee Work Hours Consent

- a. An employee willing to work at the Richland County Fair in exchange for hours at their department must submit a consent form to their department head for priorapproval from both the department head and the fair coordinator.
- b. Employees will complete the employee section. See appendix B "Employee Fair Work Consent and Authorization Form"

#### 8. Department Head Approval and Authority

- a. The department head will review the Employee Fair Work Form and determine department feasibility to allow for the requesting employee participation and authorization of department funds to pay for such work hours provided to the fair.
- b. The Department Head reserves the right to grant or decline such request(s) based on the needs of the department.
- c. Any denial of requests by the department head will not be considered disciplinary action as relates to the County grievance policy.
- d. Department heads will complete the department head section. See appendix B "Employee Fair Work Consent and Authorization Form"

#### 9. Fair Coordinator Approval and Authority

- a. The Fair Coordinator will review the Employee Fair Work Form and determine if the needs of the fair operation match with the availability and capabilities of the requesting employee.
- b. The Fair Coordinator reserves the right to grant or decline such request(s) based on the needs of the fair operation.
- c. Any denial of requests by the Fair Coordinator will not be considered disciplinary action as relates to the County grievance policy.

#### 10. Restrictions and Limitations

- a. Hours worked at the fair, in exchange for routine hours at their department, shall not exceed 8 hours total.
- b. Employees are not allowed to exceed their routine hours in a week, or enter into hours of time-and-half, in any given work week, to support the fair.
- c. Employees may not expect to work their routine work shift provided by their department, and may be offered shift times to best meet the fair operation. If these times do not work for the requesting employee, the employee may decline

participating.

- d. Employees must communicate with the Fair Coordinator to ensure assigned fair duties can safely be performed by the employee with or without accommodations.
- e. Meals and Mileage are not reimbursable.

#### 11. Employee Volunteer Hours

- a. Employees may volunteer hours in service of the fair. Employees should submit a volunteer consent form with the Fair Coordinator.
- b. Employees may use benefited time off to volunteer at the fair during their scheduled hours of county work. Benefited time off requires approval by their department.
- c. Employees must communicate with the Fair Coordinator to ensure assigned fair duties can safely be performed by the employee with or without accommodations.

#### 12. County Authority

a. The County retains authority to discontinue or modify this policy at its pleasure and without prior warning.

#### 13. Complaints

A Resolution Relating To The County Participating In The WISC Investment Fund.

## A RESOLUTION AUTHORIZING ENTRY INTO AN INTERGOVERNMENTAL COOPERATION AGREEMENT RELATING TO THE "WISCONSIN INVESTMENT SERIES COOPERATIVE" AND AUTHORIZING PARTICIPATION IN THE INVESTMENT PROGRAMS OF THE FUND.

WHEREAS, Wisconsin school districts, technical college districts, cities, villages, counties and towns may invest their monies as authorized by Wisconsin Statutes, Section 66.0603 (1m); and

WHEREAS, Wisconsin Statutes, Section 66.0301 (the "Intergovernmental Cooperation Act") provides, among other things, that municipalities may contract with other municipalities for the joint exercise of any power or duty required or authorized by law, including investment of their monies; and

WHEREAS, the Wisconsin Investment Series Cooperative (formerly known as the Wisconsin School District Liquid Asset Fund) (the "Fund") was formed as of June 23, 1988 pursuant to the Intergovernmental Cooperation Act by the adoption of an Intergovernmental Cooperation Agreement relating to the Wisconsin School District Liquid Asset Fund by Oregon School District and Sheboygan Area School District, as the initial participants of the Fund, which Agreement was amended as of July 15, 1994 and July 12, 2002 (the "Intergovernmental Cooperation Agreement"); and

**WHEREAS**, the Fund is governed by the Wisconsin Investment Series Cooperative Commission (the "Commission") in accordance with the terms of the Intergovernmental Cooperation Agreement; and

WHEREAS, the Intergovernmental Cooperation Agreement has been presented to this governing body (the "Governing Body"); and

WHEREAS, the Intergovernmental Cooperation Agreement authorizes municipalities to adopt and enter into the Intergovernmental Cooperation Agreement and become participants of the Fund; and

WHEREAS, this Governing Body deems it to be advisable for this Municipality (the "Municipality") to adopt and enter into the Intergovernmental Cooperation Agreement and become a participant of the Fund for the purpose of exercising jointly with other municipalities the power to invest their monies, so as to enhance the investment earnings accruing to each; and

WHEREAS, this Governing Body deems it to be advisable for this Municipality to make use from time to time, in the discretion of the officials of the Municipality identified in Section 2 of this Resolution, of the Fixed Rate Investment Program available to participants of the Fund; and

WHEREAS, this Governing Body deems it advisable for this Municipality to make use of, from time to time, the services provided by PMA Financial Network, Inc., PMA Securities, Inc., U. S. Bank National Association, and/or their affiliates and successors, in connection with the Municipality's utilization of the Fund.

#### NOW, THEREFORE, BE IT RESOLVED AS FOLLOWS:

Section 1. This Municipality shall join with other Wisconsin municipalities in accordance with the Intergovernmental Cooperation Act by becoming a participant of the Fund and adopting and entering into the Intergovernmental Cooperation Agreement. A copy of the Intergovernmental Cooperation Agreement shall be filed in the minutes of the meeting at which this Resolution was adopted. The President (Chairperson) (Mayor) and the Clerk (Secretary) are authorized to take such actions and execute any and all such documents as they may deem necessary and appropriate to effectuate the entry of this Municipality into the Intergovernmental Cooperation Agreement and to utilize Fund programs through PMA Financial Network, Inc., PMA Securities, LLC. U. S. Bank National Association, and/or their affiliates and successors. Section 2. This Municipality is authorized to invest its available monies from time to time and to withdraw such monies from time to time in accordance with the provisions of the Intergovernmental Cooperation Agreement, including investment in the fixed-income program of the Fund through the intermediaries PMA Financial Network, LLC and PMA Securities, LLC. The following officers and officials of this Municipality and their respective successors in office each are designated as "Authorized Officials" with full power and authority to effectuate the investment and withdrawal of monies of this Municipality from time to time in accordance with the Intergovernmental Cooperation Agreement and pursuant to the Fixed Rate Investment Program available to participants of the Fund: (List the name(s) and title(s) of the officer(s) and official(s) who will be authorized to invest and withdraw monies in and from the Fund and pursuant to the Fixed Rate Investment Program. You may have any number of Authorized Officials; attach an additional list if necessary.)

**Section 4.** This Municipality may open depository accounts, enter into wire transfer agreements, safekeeping agreements, and lockbox agreements, or other applicable or related documents with U. S. Bank National Association, and any other institutions participating in the Fund programs or programs of PMA Financial Network, LLC and PMA Securities, LLC, pursuant to Wisconsin Statutes, Section 34.05, Wisconsin Statutes, Section 120.12(7) (if applicable) and, when directed by one of the Authorized Officials, Wisconsin Statutes, Section 66.0603. PMA Financial Network, LLC and/or PMA Securities, LLC are authorized to act on behalf of this Municipality as its agent with respect to such accounts and agreements.

Section 5.
