Diversion Program: by Attorney Jeff Erickson

There are people that fall through the cracks. They are low to moderate risk and do not fit in treatment court. Parameters are the same, non-violent. The difference is the DA signs either pre-plea or post-plea with a Diversion Agreement including more structure, conditions and consequences. In Crawford County, there is a peer specialist. If we implemented this program, we would need more funding with the hope we would save money because we would potentially have fewer people in jail and on probation. Participants would report bi-weekly for 60 days and have 4 tests per month. The judge would need to accept the diversion agreement. Atty Erickson will e-mail out additional information.

Drivers License Restoration Program:

For people that are eligible to restore their license but they do not know how to do it. LIFT WI.org. Discussion took place on pop-up clinics.

Quarterly Treatment Court Update:

Discussion on treatment court fees which would cover the cost of bracelets and testing. At this time, there is no cost to participants in treatment court. Discussion on incentives and on sanctions. Drug testing has become expensive. We have not yet hit the maximum from the grant but also haven't had a full group. Additional discussion on developing life skills and community service hours. Brandi and Savannah will draft a policy.

Waitlist Acceptance Policy:

We still have 12 participants. The next graduation will be in January. There is still a wait-list. If participants take longer to graduate then it pushes back the time to be accepted. Discussion on drug endangered children and setting priorities on applicants.
