 - Roxanne Klubertanz-Gerber reviewed the transportation budget with the committee. Currently the budget target is 75% and the program is currently at 64.5% utilization.
- 7) Program updates:
 - Roxanne reported an increase in ridership in both the Driver Escort program and Bus Program. Driver Escort has seen a 12% increase and the bus program has seen a 35% increase.
 - Roxanne reported that the program will be offering a fall color ride trip going to Oakwood and to Riverside restaurant in Spring Green.
 - The bus program will be offering a trip through the Rotary Lights in December.
 - The ADRC will be providing Dementia Live to both transportation and nutrition drivers.
 - Currently, there is one opening for a bus driver and have ongoing needs for volunteer drivers.

- 9) Citizen Comments:
 - Robert Sheire reported that there will be a blood drive on November 15, 2023. There are currently 49 signed up and the Red Cross is needing volunteers.
