September 24, 2025

The Richland County Campus Reconfiguration Standing Committee convened on September 24, 2025 in person and virtually at 5:00 PM in the County Boardroom of the Richland County Courthouse.

Call To Order: Committee Chair Turk called the meeting to order at 5:00 PM.

Roll Call: County Clerk Kalish conducted roll call. Committee members present: Randy Schoonover, Gary Manning, Rod Perry, David Turk, Melvin "Bob" Frank, and Steve Williamson. Committee member(s) absent: Steve Carrow.

Verification Of Open Meetings Law Compliance: County Clerk Kalish confirmed the meeting had been properly noticed.

Approval Of Agenda: Motion by Frank second by Schoonover to approve the agenda. Motion carried and the agenda declared approved.

Approval Of Minutes From August 20, 2025 Meeting: Committee Chair Turk asked if there were any corrections to the minutes from the August 20, 2025 meeting. Hearing none, Committee Chair Turk declared the minutes from the August 20, 2025 meeting approved as presented.

Public Comment: None.

Reports - Update On Assessment Of Specialized Items In Campus Buildings: Administrator Clements noted that taxidermy, rocks, and microscopes were removed by the Smart Farm, the city of Richland Center sent a list of items of they are interested in, Pine Valley would be removing items from the campus kitchen, the Foundation has removed nostalgic items (artwork and sports records), and that a piece of artwork would be donated to the AD German Warehouse Conservancy. Committee Chair Turk noted that many costumes have been removed from the theatre, county items stored on campus would need to be disposed of, a piano remains on campus, and that UW-Platteville removed all computers left on campus.

Reports – UW Redevelopment Grant Application: Administrator Clements reported that she received the budget worksheet for the grant today and will begin working on it immediately and that the funding for the tennis courts was not granted as originally believed.

Reports - SEH Update: Administrator Clements distributed update provided by SEH.

Discussion & Possible Action - Campus Property Boundaries: Administrator Clements noted that SEH will need to know the land that is to be included in their redevelopment study and Committee Chair Turk agreed. Discussion followed regarding what land should be included in redevelopment study. Supervisor Frank stated he felt that a vision of the whole thing would be helpful. Consensus was reached for SEH into include the entirety of the campus property in their redevelopment plans.

Discussion & Possible Action - Demolition Of Buildings And Associated Costs: Administrator Clements noted that direction is needed on the demolition plans for the campus buildings. Supervisor Frank noted that a focus should be placed on cutting the utilities on the buildings proposed buildings to be demolished. Motion by Manning second by Frank to obtain bids for the demolition of the classroom

and science buildings with inclusion of the science building as another prospective building to be demolished. Motion carried and item forwarded to the Executive and Finance Standing Committee for further consideration.

Discussion - Campus Infrastructure: Committee Chair Turk noted that the current utilities infrastructure may or may not be adequate for future use(s) of the campus property. No action taken on this item.

Discussion & Possible Action: Set Future Meeting Date(s): Next meeting scheduled for 4 PM on October 22, 2025.
