Resolution Approving The Town Of Ithaca's Rezoning A Portion Of Parcel 016-3411-0000: Resolution No. 25-51 approving the Town of Ithaca's rezoning of a portion of parcel 016-3411-0000 was read by County Clerk Kalish. WHEREAS the usual way that zoning is accomplished in the unincorporated areas of counties in Wisconsin is for the county to adopt county-wide zoning and for the town boards that wish to do so elect to be covered by that zoning, but there is an alternate, seldom-used method whereby towns, with the permission of the county board, can adopt their own zoning ordinances, and

WHEREAS the Town of Ithaca is one of two towns in Richland County that has elected to have town zoning and Wisconsin Statutes, section 60.62(3) provides that the County Board must not only approve the Town's initial zoning ordinance and zoning maps but the County Board must also approve any rezonings before they become effective, and

WHEREAS representatives of the Town of Ithaca met recently with the Zoning and Land Information Committee and requested that the County Board approve the Town's rezoning of a portion of parcel 016-3411-0000 from the Farmland Preservation District to the Ag/Residential Zoning District in the Town of Ithaca's Zoning Ordinance and the Zoning Land Information Committee has carefully consider this matter and is now recommending that the County Board approve this rezoning.

NOW, THEREFORE, BE IT RESOLVED by the Richland County Board of Supervisors in accordance with Wisconsin Statutes, section 60.62(3), that approval is hereby granted for rezoning the following-described 10.9 acre parcel from the Farmland Preservation District to the Ag/Residential Zoning District in accordance with the Town of Ithaca's Zoning Ordinance:

A parcel of land being part of the NE and SE ¼'s of the NE ¼ of Section 34, Town 10 North, Range 2 East, Town of Ithaca, Richland County, Wisconsin, to wit:

**Reports - County Administrator Update:** Administrator Clements provided updates on the following items: 2026 budget progress, County Board technology survey results, Campus Reconfiguration Committee updates, office composition of Emergency Management and Emergency Services, upcoming Lou Everett training, use of gym on campus, Tyler Time and Attendance implementation, RFP process for Corporation Counsel services, items on campus and UW Redevelopment Grant, and the committee structure survey. Brief discussion followed regarding the timing of communication of significant events to County Board Supervisors.

**Reports – Legislative Update:** None.

Discussion & Possible Action: County Board Rules Related To Public Comment: Supervisor Engel noted his desire to amend the Rules of the County Board to include a second three-minute opportunity for public comment. Supervisor Gill noted concerns with the requirement that public comment be germane to an agenda item and was in favor of Supervisor Engel's suggestion. Supervisor Schoonover noted that the commentor's information is provided on the public comment form, suggested a three-minute moment of silence be observed to illustrate the time one is given for public comment, and stated that he felt three minutes is sufficient. Supervisor Engel noted that if three minutes is not enough, other options should be given. Supervisor Carrow stated he was fine with public comment not being germane to an agenda item. Supervisor Frank noted that a commentor's contact is provided on the public comment form in the event follow up is desired. Corporation Counsel Windle noted that accommodations for those that wish to make a public comment can be arranged if desired and/or needed. #### **ORDINANCE NO. 25 - 20**

Amendment No. 628 To Richland County Code of Ordinance Chapter 119- Zoning Relating To Parcel 010-1242-4000.

The Richland County Board of Supervisors does hereby ordain as follows:

- 1. The County Board, having considered the following factors, hereby finds that the following rezoning is in the best interests of the citizens of Richland County:
  - (a) Adequate public facilities to serve the development are present or will be provided.
  - (b) Provision of these facilities will not be an unreasonable burden to local government.
  - (c) The land to be rezoned is suitable for development and development will not cause unreasonable water or air pollution, soil erosion or adverse effects on rare or irreplaceable natural areas.
  - (d) Non-farm development will be directed to non-agricultural soils or less productive soils.
  - (e) Non-farm development will be directed to areas where it will cause minimum disruption of established farm operations or damage to environmentally sensitive areas.
  - (f) Non-farm development will be encouraged to locate so as to leave a maximum amount of farmland in farmable size parcels.
  - (g) Non-farm residential development will be directed to existing platted subdivisions and sanitary districts.
- 2. Richland County Code of Ordinance Chapter 119- Zoning, which was adopted by the Richland County Board of Supervisors on May 20, 2003, as amended to date, is hereby further amended as follows:

Thence South 84° 26' East, 297.90 feet along said centerline;

Thence South 84 14' East, 245.80 feet along said centerline;

Thence North 05° 06' East, 440.04 feet to the North Line of said Southeast Quarter (SE 1/4);

Thence North 89° 15' 25" West, 887.95 feet along said North Line to the point of beginning;

Said parcel of land being a part of the Northwest Quarter (NW ¼) of the Southwest Quarter (SE ¼) of Section Twelve (12), Township Nine (9), Range One (1) West, Richland County, Wisconsin.





## Annual Return on Investment










# County Contributions as % of SWWRPC Revenue

#### **County Benefits and Return on Investment**




For every \$1 Richland County provides to SWWRPC, the county receives \$1.77 in annual capacity building, economic development, and other planning services. This figure is in addition to services provided via contracts and grants.


Richland County's 2025 investment of \$18,292 amounts to \$1.07 per county resident, and enables us to provide \$32,424 of services. This due to our ability to leverage your investment for an additional \$7,740 from the U.S. Economic Development Administration (EDA) and \$6,413 from the Wisconsin Department of Transportation (WisDOT).

Working with us also results in savings due to billable rates that are lower than those offered by private, for-profit consultants. On average, our services cost between \$60-\$90 per hour, compared to \$100-\$180 per hour from private firms performing similar work. This is due to our diverse revenue streams, a lean staffing model, strong relationships throughout the region, and a non-profit structure which is affordable for small communities.

#### Your investment, Your asset

SWWRPC Commissioners and staff believe that we are stewards of your investment. This is *your* organization, and we strive to grow your investment through investments of our own. We continue to leverage your county funding to fund our operations, and we make catalytic investments in new sources of business investment such as our Revolving Loan Fund. The result is both a reduction in county funding as a percent of our overall budget, and a significant growth in your assets. **County contributions have only increased 27% since 2011 while the organization's assets, inclusive of revolving loan funding for small businesses, has grown 193%.**

#### **Capacity Building Projects**

- ADRC Transit Plan: SWWRPC uses county and WisDOT funding to write the 5-year Locally Developed Coordinated Transit Plans required for grant funding to support vehicle purchases and operating expenses. In 2024, we provided Richland County over 200 hours valued at \$15,500 in public engagement, data analysis, meeting facilitation, and plan writing services. Due to our work on these plans, Richland County received \$482,845 between 2021 and 2025 (an average of \$96,569 per year) to fund vehicles, volunteer driver mileage, and department overhead in support of ADRC transit services. These plans also enable the Southwestern Wisconsin Community Action Program to secure operational and vehicle funding for transit services serving Richland County. Since 2021, SWCAP has been awarded \$3.4 million for services that support elderly and disabled residents.
- **GIS Mapping:** SWWRPC applies county and EDA funds for a variety of GIS maps used by partners throughout the region. All of these programs are cost-effective due to efficiencies created by our regional GIS platform, staff expertise, and processes.

- Richland Highway Department Infrastructure Map: SWWRPC staff worked with Highway Commissioner Josh Elder to develop an interactive GIS map of all highway infrastructure that will be used for capital improvements planning and management. This project was fully funded by our WisDOT grant funding with a total 2024 investment of \$3,545.
- Regional mapping tools: SWWRPC applies county and EDA funding to a variety of GIS maps used by local community and economic developers, including a regional Constructability Map, financial asset map, broadband asset map, and a Story Map of school performance data. From 2020-2023, 280 hours of staff time valued at \$18,200 were spent on the creation of these maps with an additional 202 hours (\$12,349 in labor) in 2024. We have also used our GIS tools to support businesses seeking to locate in the county.
- **UW-Platteville Design Support:** SWWRPC staff frequently connect communities with UW Platteville (UWP) Senior Design initiatives that apply student and professor knowledge to local issues. Each project is estimated to provide the equivalent of \$10,000 of professional services. We have engaged or partnered to engage UWP students to assess nutrient tradition options in Cazenovia (2021), conduct preliminary design on a new fire station for Yuba (2022), study flood reduction and water quality improvement impacts of re-meandering Fancy Creek in Rockbridge Township (2022), and analyze the long-term historic and projected solvency of municipal finances (2023). These projects resulted in \$40,000 of free technical assistance to the county.
- **Opioid Needs Assessment:** Richland County partnered on a regional Opioid Needs Assessment in 2022, providing \$3,000 for interviews, data analysis, and plan writing. We used your county contributions to cover the cost of interviewing state and national experts, and seek opportunities for coordination. The per-county fee for this work would be approximately \$10,000 if not for the efficiencies of a regional approach.
- **Technical Training:** SWWRPC staff serve as the liaison for regional technical assistance trainings offered by state partners. In 2021 and 2022, we partnered with the Wisconsin Department of Natural Resources (DNR) for sessions on Community Redevelopment Funding, and Managing Flood Damage to Roadways. Together, the coordination, marketing, and managing of this event was valued at \$1,500.
- **Regional Coordination:** Beginning in 2022, we facilitated regional meetings designed to foster cross-county collaboration and best-practice sharing. GIS Coordinator Jaclyn Essandoh facilitated two meetings of the region's GIS staff, continuing a practice we began in 2015. Executive Director Troy Maggied facilitated eight meetings of county broadband staff and continues to facilitate quarterly meetings of county board chairs and administrators. Our staff time was paid for by county contributions and equaled 165 hours valued at \$5,500.
- **Emergency Management Survey:** In late 2022, we helped county Emergency Management Directors (EMD) develop a survey for their Integrated Preparedness Planning Workshop. Each county is required to develop and deploy this survey, and we

facilitated a regional process to develop the survey, deliver it in an online format, collect responses, and analyze the results. Our additional capacity reduced each county's workload and provides a regional picture of natural hazard risks and vulnerability. This process took approximately 38 hours of staff time valued at \$2,850.

#### **Economic Development Projects**

- **EDA Investments:** SWWRPC is recognized as the EDA's Economic Development District (EDD) and serves as the broker for EDA grant funding. The historic benefits of this partnership are significant:
  - Since 1990, we have secured two Public Works grants for \$1.43 million to fund the development of 132 new industrial acres in Richland Center. These projects created \$6.78 million of property value and annually generate over \$150,000 in property taxes.
  - EDA planning grants fund the administration of our regional RLFs discussed below, providing 603 hours of staff time valued at \$42,236 in 2024.
  - O During 2025, SWWRPC staff worked with regional economic development staff to update the 5-county Comprehensive Economic Development Strategy which now extends from 2024-2029. This effort included significant engagement with county and local economic and community development staff, and took 1,014 hours of SWWRPC staff time valued at \$70,772. The CEDS is the region's primary economic development strategy and necessary for local communities to become eligible for federal funding.
- Main Street Bounceback Program: From 2020-2022, SWWRPC administered the
  Main Street Bounceback Program which provided 27 businesses with \$10,000 grants to
  start or expand in three communities across Richland County. Administering this
  \$270,000 was paid for by the Wisconsin Economic Development Corporation (WEDC),
  but required hours of up-front set up, scoping, contracting, and administrative
  preparation which was funded by your county contributions and our EDA funding.
- **Revolving Loan Funds:** SWWRPC administers a \$1.8 million RLF portfolio. Currently, \$362,000 is lent to Richland County businesses who are leveraging this against an additional \$1,137,500 in private financing and resulting in the creation or retention of 28 jobs. We use our EDA funding and county contributions to cover the cost of RLF administration, marketing, and application processing. We also conduct follow-up meetings with borrowers to ensure they're successful and identify additional support they may need.
- Community Branding: During 2021 and 2022, SWWRPC secured EDA funding for branding and logo development in Richland County, Richland Center, and Boaz – a process which included multiple community and partner engagement meetings. This process, with SWWRPC staff time valued at \$5,600 and an additional \$15,000 in consulting time from Kristin Mitchell Designs, was provided and paid for through the 2020 EDA Flood Recovery and Economic Resiliency Grant.

- **Prosperity Southwest Wisconsin:** SWWRPC staff serve as the administrator for Prosperity Southwest Wisconsin (PSW), the six-county Regional Economic Development Organization. Working closely with county economic development partners, we assist with procurement of regional grants and projects that have a multicounty impact. These include the regional housing studies mentioned below, administration of a \$121,000 BEAD Broadband Planning grant, a regional workforce needs mapping project valued at \$50,000, and a Talent Marketing Grant valued at \$60,000. All of these projects were secured by our grant writing efforts. We are now working with PSW to pursue a \$50,000 grant to fund AI training for Economic Development professionals in the region.
- Entrepreneurship Accelerator: In 2021, SWWRPC partnered with UWP to create a local entrepreneur accelerator called the IDEA Hub, located in Platteville and serving southwest Wisconsin. This \$1.1 million project is funded in equal parts by the EDA and local partners. We were able to bring \$70,000 of cash match funds from PSW, and provide staffing support for the project.
- **Connect Communities:** In 2022, SWWRPC partnered with WEDC to serve as a regional Connect Communities administrator which provides free technical assistance to small communities participating in the program. Lone Rock currently participate in this program and have access to technical assistance, training, funding resources, and networking opportunities to help with community development efforts. Our work is funded by EDA planning grants and your county contributions. In 2024, SWWRPC secured a \$50,000 grant from WEDC to fund our staff work in these communities. This work includes basic goal-setting and strategic planning, as well as providing technical assistance on marketing and events.

#### **Planning Projects**

- **Housing Studies:** In 2025, SWWRPC updated our six-county housing study project, which was funded by a \$5,000 investment by Richland County. These plans are each valued at \$15,000 of staff time each, and plans are currently available for Boaz, Cazenovia, Lone Rock, Richland Center, and Viola.
- **Strategic Planning:** In 2020 and 2021 we lead a strategic planning process to help the county identify opportunities and challenges for the next 3-5 years. The total cost of this process is valued at \$8,000, but cost was able to be funded through the EDA grant at no additional cost to the county.
- **Comprehensive Planning:** The Boaz, Lone Rock, and Richland Center Comprehensive Plans were completed between 2020 and 2022, and focus on helping these communities leverage their greatest assets, including Richland County's natural beauty, available land for residential growth, quaint downtowns, access to unique recreation opportunities and events, and their strategic location along a state road leading to Madison. Each of these planning projects are valued at \$15,000 to \$25,000 depending

on community size, but were able to be funded through this EDA grant. We offer assistance with implementation using a plan-do-study-act continual improvement process to ensure they move forward with proposed initiatives.

- **Broadband Planning:** Due to SWWRPC's capacity and staffing flexibility, the region had staff available when the Wisconsin Public Service Corporation provided over \$121,000 in funding to Prosperity Southwest. PSW Contracted with SWWRPC to partner on several initiatives that will make the region more competitive for future Broadband funding. This included identifying public areas in the region that would benefit from free, public WIFI. These areas include community centers in Boaz, Cazenovia, and Yuba.
- Climate Adaptation: SWWRPC is currently developing a work plan to support counties and municipalities prepare for the pending impacts of climate change. Few consultants in the region are prepared to work on these issues or have access to funding and relationships to meet these future needs. Our primary areas of focus are economic resiliency, energy security, climate migration, and asset management. To support this work, SWWRPC spent 176 hours valued at \$10,729 to develop a map of climate scenarios and risks to industries in the region.
- **Watershed Planning:** Regional Planning Commissions are eligible for grants that municipalities, private businesses, and non-profits are not. In 2021 we served as the grant administrator and fiscal agent for a \$15,000 project studying stream and wetland restoration on Fancy Creek in Rockbridge Township. The project is designed to assist with flood reduction and water quality improvements, and is funded by a \$10,000 Department of Natural Resources grant, \$2,000 in cash contributions from SWWRPC, and \$3,000 from in-kind donations from the Wisconsin Wetlands Association.
- Grant Opportunity Analysis: In 2021, SWWRPC spent \$6,800 in labor and mileage
  funded by EDA and county contributions to assist the Village of Yuba determine
  eligibility for a CDBG Public Works grant to assist with constructing a new fire station.
  This work included conducting a survey of the Fire District to evaluate income levels, as
  well as follow-up door-to-door interviews with residents who did not initially respond
  to the survey.
- **Resiliency planning:** SWWRPC is currently working with former Richland County EMD Darin Gudgeon, County Board Supervisor Steve Carrow, and a diverse set of other county stakeholders to identify projects that will help the county withstand and bounce back from natural or economic disasters. This is the first initiative in a region-wide process to support counties and municipalities prepare for the pending impacts of climate change, economic downturns, and other future risks. Few consultants in the region are prepared to work on these issues or have access to funding and relationships to meet these future needs. Our primary areas of focus are economic resiliency, energy security, climate migration, and asset management.

- Recreation Planning: In 2022, SWWRPC staff assisted the county, Boaz, and Lone Rock develop Outdoor Recreation Plans required for them to be eligible for DNR recreation grants. This project cost each community \$3,000 and was leveraged to bring in an additional \$6,000 of EDA funding for each community, returning \$18,000 to an initial \$9,000 investment.
- Data Insights: One of our primary duties is to collect, analyze, and present findings on data. We do this both proactively and upon request. In the past two years, we have helped Boaz, Cazenovia, Lone Rock, Richland Center, Richland County, Richland Economic Development, and Viola by providing data insights used to address their needs and pursue grant funding. Collectively, these projects have taken over 140 hours valued at \$12,880.
- **Regional and Statewide Support:** In addition to local projects, we are also involved in regional and statewide planning efforts that ultimately benefit Richland County.
  - In 2024, SWWRPC staff led by Economic Development Specialist Kate Koziol coordinated the state's first-ever Connecting Entrepreneur's Conference in Platteville. SWWRPC spent nearly 100 hours valued at \$5,930.
  - o In 2022, SWWRPC staff facilitated a statewide strategic planning process for the Badger State Sheriffs Association (BSSA) to help them identify ways to effectively train, fund, and support sheriffs throughout Wisconsin. This process was funded by BSSA and valued at \$5,000.
  - O As a result of our dual role as an EDD and Administrator of PSW, our Executive Director Troy Maggied has been asked to participate in a statewide process to align state and federal funding programs. Our goal is to improve the development and acquisition of EDA and WEDC grants, and to increase communities' access to this funding. This process involved weekly meetings, two statewide events, and two national workshops taking approximately 296 hours valued at \$27,232. The outcome of this project is greater coordination between state and federal economic development agencies that has helped align funding for our communities.

NOW THEREFORE BE IT RESOLVED by the Richland County Board of Supervisors that approval is hereby granted for the Aging and Disability Resource Center of the Department of Health and Human Services to apply for and accept a 2026 Section 5310 Operating Grant from the Wisconsin Department of Transportation in the amount of \$33,590.93, and

BE IT FURTHER RESOLVED that the grant requires a 50% minimum County match which can be either cash and/or in-kind funding which will be accomplished by Section 85.21 non-Federal transportation funds, program revenues, indirect costs supported by Health and Human Services Fund # 560, and

BE IT FURTHER RESOLVED that approval is hereby granted for the grant funds to be spent in accordance with the terms of the grant and the Director of the Health and Human Services Department. #### **Purpose of Position**

Responsible to manage the operations and staff and to develop and implement comprehensive emergency services for Richland County in accordance with local, state, and federal laws, rules, regulations and plans.

#### **Essential Duties and Responsibilities**

The following duties are normal for this position. These are not to be construed as exclusive or all-inclusive. Other duties may be required and assigned.

- Establishes, maintains and directs Emergency Services functions ensuring compliance with local, state and federal requirements.
- Maintains knowledge of current laws and regulations. Ensures that current ordinances and resolutions support the legal basis for the programs, including Federal and State mandates.
- Prepares, recommends, and monitors annual budgets and capital improvement plans for the Departments.
- Develops, implements and monitors policies, practices and plans for the Departments.
- Ensures all local, state, and federal reports are processed in an accurate and timely manner.
- Oversees appropriate preparation and maintenance of documents and records.
- Functions as Facility Manager for Emergency Services Building.
- EMS DUTIES:
  - Ensures Service License and operational plan are maintained and submitted to the State and that EMS staff maintain necessary certifications.
  - Manages staff to ensure compliance with work rules and procedures.
  - Advises the County administrator on matters regarding EMS.
  - Functions as liaison between Service and Medical Director, Joint Ambulance Committee, and County Board.
  - Manages EMS Staff ensuring daily operational tasks are completed.
  - Ensures ambulance coverage as required per statute. Provides coverage when needed.
  - Meets frequently with hospital emergency room staff.
  - Responds to ambulance calls and provides patient care.
  - Completes monthly staff schedule.
  - Ensures the positions of Training Officer, QA/QI Designee, WARDS Designee,
     Infection Control Officer are filled and reported to the State.

- Updates medical protocols in coordination with Medical Director and Training Officer.
- Establishes and maintains quality assurance/improvement program.
- Coordinates staff training and recruitment including CPR training and ensures
   Service is utilizing industry best practices and meets state inspection standards.
- Supervises Medicare and Medical Assistance reporting and third-party billing and other office activities.
- Ensures OSHA 1910 regulations are met.
- Creates and maintains infectious disease plan.
- o Functions in a command staff role during a multi-casualty incident.
- Assists Richland Center Hospital with policies in EMS.
- Creates, maintains and distributes policies and Standard Operating Procedures (SOPs) approved by the medical director.
- Assists fire departments, law enforcement and first responders in purchasing and maintenance of medical equipment and supplies for emergency response.
- Oversees acquisition and maintenance of department equipment, vehicles and supplies.
- Prepares a variety of reports, data, analysis and recommendations.
- Manages staff: Makes hiring, discipline and discharge decisions. Assigns and schedules work activities, trains, mentors, monitors and evaluates work. Performs succession planning.
- Attends and participates in meetings and seminars related to the Departments.
- Attends training as required to stay current in changes with EMS.
- Responsible for EMS for 24/7 on-call as necessary.
- Performs other duties as assigned or apparent.

#### Minimum Training and Experience Required to Perform Essential Job Functions

NEMT or Paramedic with three years relevant experience; or any combination of education and experience that provides equivalent knowledge, skills and abilities for this position. Current AEMT License, ICS 100,200,300,700, 800 and CPR Certification. Valid Driver's license. Management preferred.

#### Physical and Mental Abilities Required to Perform Essential Job Functions

#### **Language Ability and Interpersonal Communications**

- Ability to communicate effectively, orally and in writing, and have strong positive customer service skills.
- Ability to establish and maintain effective working relationships with others.

#### Skills, Knowledge and Abilities

- Knowledgeable in all areas of pre-hospital emergency care, emergency medical protocols and policies, and federal, state and local laws and regulations regarding prehospital emergency care and billing.
- Working knowledge of Wisconsin Administrative Codes and Wisconsin State Statutes related to EMS and Emergency Management.
- Knowledge of ICS training level 100, 200 & 300 and NIMS IS-700 & IS-800.

- Knowledge of Microsoft Word, Excel, Access and Outlook software.
- Ability to develop and implement goals and objectives; plan, coordinate, direct and
  evaluate the work of others; develop and implement policies and procedures; and to
  supervise personnel in a manner conducive to efficient performance and high morale.
- Ability to set policies and goals for the department with top management guidance.
- Ability to perform widely varied work involving complex and significant variables requiring analytical ability and inductive thinking.

#### **Physical Requirements**

- Ability to exert moderate physical effort in sedentary to light work, involving standing, walking, stooping, kneeling, and crouching. Ability to handle, finger, and feel. Ability to lift, carry, push, and pull up to 100 pounds.
- Ability to bend, lift and secure patients.

#### **Working Conditions**

- Work is performed in indoors and outdoors settings as well as emergency vehicle.
- Ability to work under potentially hazardous and uncomfortable conditions in environmental factors including but not limited to temperature variations, odors, toxic agents, violence, noise, vibrations, wetness, close quarters, disease and/or dust.
- This position may be occasionally exposed to mental effort and stress as well as angry, intoxicated or confused persons.
- This position frequently performs work under high attention to detail and deadlines.

#### **Special Requirement**

As a post-offer pre-employment condition, a criminal background check must be completed and passed. Richland County may disqualify an applicant if the position's responsibilities are substantially related to the applicant's criminal history. Wisconsin's Fair Employment Law, s.111.31-111.395, Wis. Stats., prohibits discrimination because of an arrest or conviction record. Management reserves the right to make employment contingent upon the successful completion of the background check. The cost of the background check will be covered by Richland County.

All efforts should be made to use the assigned department purchase card in accordance with the Purchasing Card Policy. All reimbursements requests should be submitted for bi-weekly payroll monthly. Prior year expenses will not be paid after February 28, of the following year. in the year the expenses were incurred.

#### Lodging:

Policy as to reimbursement for overnight lodging:

- a. Overnight lodging may be needed to attend a conference, seminar, training, etc. When a Department Head determines the need for lodging, the following factors will be taken into consideration; distance needed to travel, number of individuals attending, mileage reimbursement cost, start and end times, and potential overtime costs.
- b. Actual expenses for the standard room should not exceed the governmental rate. Department heads have the authority to approve lodging expenses for employee attendance at training and seminars if the standard room rate is the same as or does not exceed the government rate.
- c. Approval by the <del>Department Head</del> County Administrator is required where lodging expenses for employee attendance at training and seminars will exceed the government rate by more than 15%.
- d. All registration fees are to be paid in advance so as to take advantage of any available discounts. The department purchase card should be used whenever possible.
- e. All lodging reservations are to be made in advance and the proper paperwork be in place. County tax exempt certificates must be submitted when making reservations so as to eliminate sales and room tax charges on lodging.
- f. Sheriff's Department prisoner transports are exempt from the requirement to comply with the governmental rate for lodging.
- g. Employee attendance at training and seminars where lodging expenses are involved which are more than the governmental rate and where the County Administrator will not approve the costs exceeding the governmental rate may be attended by the employee if the employee agrees to pay the lodging costs which exceed the governmental rate.
- h. Receipts must be submitted in all cases with proof of payment.
- i. When more than one employee is in attendance, sharing rooms when appropriate is encouraged.
- j. When an officer or employee is accompanied by his or her spouse, the additional expense over that otherwise reimbursed shall be paid by the individual employee.
- k. All reimbursements requests should be submitted for bi-weekly payroll in the year the expenses were incurred.

#### Meals:

Policy as to reimbursement for meals:

a. Actual expenses for meals shall be reimbursed in amounts not to exceed the following per meal amounts:

Breakfast - \$10.00

Lunch - \$12.00

Dinner - \$23.00

\$25.00/day. If a convenience fee is charged for use of a debit/credit card, it will be reimbursed on top of the \$25.00/day costs.

- b. Alcoholic beverage is not a reimbursable expense.
- c. The above limitations shall not include applicable sales tax which shall be reimbursed, and gratuities which shall be reimbursed up to a maximum of 15% of the amount of the bill.
- d. Detailed, itemized receipts shall be required in all cases. (Lodging invoices indicating "room service" charges will not suffice.)
- e. Reimbursement of meals is only warranted when traveling out of the county, on county business. All employee meal reimbursements must be approved by the Department Head.

#### Mileage:

Policy as to reimbursement for mileage:

- a. Mileage for county related business will be reimbursed at the State rate IRS rate in effect when the miles were driven.
- b. Reimbursement for mileage will be based on miles driven by the most direct route between the county office building the employee works in and the destination.
- c. For trips that start or end at an employee's home, the mileage reimbursed will be the less of the actual miles driven between the home and the destination or the mileage between the county office building and their location.
- d. In situation where there is a question on the number of miles reported, Google Maps will determine the number of miles being reimbursed.
- e. Employees will not be reimbursed for personal stops made off the direct path.
- f. Employees are not to be reimbursed to travel to and from work.

#### Parking:

Parking charges for county related business must be submitted for reimbursement with receipts.

#### Registration Fees:

When registration fees for attendance at a duly authorized convention, seminar or meeting include the costs of meals and/or lodging, no other reimbursement shall be allowed.

#### **Expense Vouchers:**

Expense vouchers must be submitted to the County Clerk's Office within 90 days from the time that the expense is incurred. except that the Audit team may grant an extension when that committee deems it appropriate. Approved expenses shall be paid to the employee once a month upon receipt of the expense voucher. Employees are expected to use the standard expense reimbursement form.

Approved expenses shall be paid at the first payday after approval, by direct deposit to the employee's account in the same manner as salaries are paid. Approved expenses for reimbursement through payroll shall include only lodging, meals, mileage, parking and registration fees.

Proposal To Create An At-Large Supervisor Position Or For Hiring Me As An Interim Agency Liaison Administrator

August 13, 2025

Dear Sir,

I propose creating a new position for a project I would like to execute for the county as an At-Large Supervisor or for the Board to retain me to do the work as an Administrator, with the same pay that a supervisor is paid and for travel costs. My reading of statutes with the county counsel's corrections suggests a self-organized county can make up whatever it wants.

My resume is attached. Harvard lost my records. My military record has been sealed by the 3<sup>rd</sup> Circuit Court of Appeals. But my Oxford diploma is available.

I have never held public office before, but I am considering running for a seat in Congress or for Governor next year, and I would like to get my feet wet in county government before I drown in ignorance which county counsel kindly emphasized is possible.

In other words, I have no idea what to do, but I sense something must be done. My resume shows Washington internships. I learned a lot about the way things work. It is clear to me that the recent legislation of President and Congress was only testing the waters, and that cuts in Medicare and Social Security will follow. That, with a certainty will lead to deaths, and 120 million Americans who rely on them could die. Because I helped Senator Kennedy collect Republican support for his bills that made him the most successful senator in history, I learned how to find the middle road. I think I can stop the killing before an entire generation of children is lost from contaminated content in school books, or all the seniors die from sickness. This congressional district is the key to the nation. As this district goes, so goes the state. As Wisconsin goes, so goes the nation.

In the process, I think I may be able to free the county from years of waiting to fix things. I came across a February 2025 radio show in which two of the members of this Board lamented about the deterioration of county buildings and the threat to the

public of questionable courthouse security. The estimate was 25 years to solve these problems. I think I can do better. Like *Little Toot, the Happy Harbor Tug*, I think I can.

I can because in my White House days I learned how to connect the efforts of agencies to get the job done, and I was assigned to be the special projects officer in all of my military units. This county houses two engineering units that have the capacity to assess costs for all the improvements, and I speak their language. I prepared plans for special forces operations for senior command approval. I can do the same by touching base with those commanders, and their commanders in Milwaukee, and if I have a solid title, like At Large Supervisor, I believe the state Adjutant for the Guard will meet with me and help me put together a construction schedule. I also did fixer uppers for my father, the master carpenter, so I know what estimates should look like.

I suggest that the Democratic governor will be happy to back my proposal for improvements in this county and the others in this congressional district, to publicize that the Democrats are helping the cities here, and that the Republican Assembly will try to top that to show the Republicans are helping even more. The Republicans did so to help the homeless. This is the battleground. I intend to go to Washington to lobby for federal money to add to the pennies the state finally approves. And I can draft the press releases that show which party gave more. I did the same for Alice Rivlin in the White House Office of Management and Budget. I can do what no one else can do. I may fail. But if I do, Mr. Trump may jump in alone to help a campaigner on the Trump-Kennedy team, myself.

In the process, I may also find a stable place to live in the county and qualify to fill a normal supervisor position when I really know what I am doing. The at-large supervisory spot will also be my internship. I am really good with internships. But I would need some pay to cover rent, and trips to other National Guard units. This Board may only meet once a month. But I would have to go to a new guard unit every week. I need to be one of them, and they will come through for me and put this county back together again. In short, I dream of things that never were, and ask, why not.
